# Q-CHARACTERS AND MINIMAL AFFINIZATIONS

#### Abstract

Every finite-dimensional irreducible representation of a (classical) affine Lie algebra has quantum analogues, but these are generally 'larger' than their classical counterparts. Among the quantum analogues of a particular classical representation, some (usually one) are 'minimal' in a certain precise sense. This paper studies the structure of these minimal representations when the underlying finite-dimensional Lie algebra is of rank 2 . We also compute their q-characters in some cases.

## Introduction

Quantum affine algebras are the simplest infinite-dimensional examples of quantum groups. The classification of the finite-dimensional irreducible representations of quantum affine algebras is well known, but their structure is still not well understood. An important tool for studying the representations of quantum affine algebras is their $q$-character; in particular, this invariant is sufficiently fine to distinguish different representations up to isomorphism. The purpose of this paper is to describe a technique for computing $q$-characters.

The method is applied to the 'minimal' affinizations: every finite-dimensional irreducible representation of a (classical) affine Lie algebra has quantum analogues, but these are generally 'larger' than their classical counterparts. Among the quantum analogues of a particular classical representation, some (usually one) are 'minimal' in a certain precise sense. It is known that every finite-dimensional irreducible representation is a subquotient of a tensor product of minimal affinizations.

After some preliminary material, we treat the affine $A_{2}$ and $C_{2}$ cases in Sections 2 and 3 , respectively. The methods used involve the construction of exact sequences of representations involving the representation to be studied together with certain
so-called 'fundamental' representations. The structure and $q$-character of the fundamental representations is known, hence the exact sequences enable those of the representation under consideration to be obtained. The exact sequences we obtain enable us to compute the $q$-characters of minimal representations in the $A_{2}$ and $C_{2}$ cases by an inductive argument. In the $A_{2}$ case a closed formula for the $q$-character is obtained; in the $C_{2}$ case, an algorithm is given which enables the $q$-character to be computed for any given minimal representation.

For the affine $G_{2}$ case, treated in Section 4, the methods used in the preceding two chapters are more difficult to apply, essentially because of the complexity of the tensor product decompositions of the representations involved. Nevertheless, we have been able to determine the structure of the minimal affinizations in some cases that have not been analyzed before.

## 1. Preliminaries

### 1.1 Kac-Moody algebras

Let $n \geq 1$ be an integer, $I=\{1,2, \ldots, n\}$. Let $\mathfrak{g}$ be the finite-dimensional complex simple Lie algebra of rank $n$ with Cartan matrix $\left(a_{i j}\right)_{i, j \in I}$. Thus, $\mathfrak{g}$ is the Lie algebra over the field $\mathbb{C}$ of complex numbers with generators $x_{i}^{ \pm}, h_{i}(i \in I)$, and the following defining relations:

\left(\operatorname{ad} x_{i}^{ \pm}\right)^{1-a_{i j}}\left(x_{j}^{ \pm}\right) & =0, \quad \text { if } i \neq j
\end{aligned}

Let $\mathfrak{h}$ be the linear span of the $h_{i}(i \in I)$. Denote by (, ) a non-zero invariant bilinear form on $\mathfrak{g}$. Since the restriction of (, ) to $\mathfrak{h}$ is non-degenerate, it induces a bilinear form on the dual space $\mathfrak{h}^{*}$, which we also denote by (, ).

Let $\alpha_{i}(i \in I)$ be the simple roots of $\mathfrak{g}$, let $\Delta^{+}$be the set of positive roots, $\Delta^{-}=-\Delta^{+}$, and let

Q=\bigoplus_{i=1}^{n} \mathbb{Z} \alpha_{i}, \quad Q^{+}=\sum_{i=1}^{n} \mathbb{N} \alpha_{i}
$$

A weight is a linear functional $\lambda \in \mathfrak{h}^{*}$. Weights can be identified with maps $I \rightarrow \mathbb{C}$ in the obvious way: to $\tilde{\lambda}: I \rightarrow \mathbb{C}$ corresponds the unique weight $\lambda \in \mathfrak{h}^{*}$ such that

\lambda\left(h_{i}\right)=\tilde{\lambda}(i)
$$

We shall often confuse these two notions of weights in the following.
Denote by

$$
P=\{\lambda: I \rightarrow \mathbb{C} \mid \lambda(i) \in \mathbb{Z} \quad \forall i \in I\}
$$

the set of integral weights, and by

$$
P^{+}=\{\lambda: I \rightarrow \mathbb{C} \mid \lambda(i) \in \mathbb{N} \forall i \in I\}
$$

the set of dominant integral weights. The fundamental weights $\lambda_{i} \in P^{+}(i \in I)$ are the dominant integral weights such that

\lambda_{i}\left(h_{j}\right)=\delta_{i j} \quad \forall i, j \in I
$$

Denote by $\leq$ the partial ordering on $P$ given by $\lambda, \mu \in P$,

$$
\lambda \geq \mu \text { if and only if } \lambda-\mu \in Q^{+} .
$$

With respect to this ordering, there is a unique maximal root $\theta \in \Delta^{+}$.

### 1.2 Affine algebras

Define

$$
L(\mathfrak{g})=\mathfrak{g} \otimes_{\mathbb{C}} L
$$

where $L=\mathbb{C}\left[t, t^{-1}\right]$ is the algebra of Laurent polynomials in an indeterminate $t$. For $x \in \mathfrak{g}, n \in \mathbb{Z}$, write $x t^{n}$ for $x \otimes t^{n} \in L(\mathfrak{g})$.

The following bracket defines a Lie algebra structure on $L(\mathfrak{g})$ :

\left[x t^{m}, y t^{n}\right]_{0}=[x, y] t^{m+n}, \quad \forall m, n \in \mathbb{Z}, x, y \in \mathfrak{g} .
$$

The bilinear form (, ) on $\mathfrak{g}$ is extended to $L(\mathfrak{g})$ by

\left(x t^{m}, y t^{n}\right)=\delta_{m+n, 0}(x, y) .
$$

Let $d$ be the derivation of $L(\mathfrak{g})$ defined by

$$
d\left(x t^{m}\right)=m x t^{m} \quad \forall m \in \mathbb{Z}, x \in \mathfrak{g} .
$$

Define a bilinear map $\psi: L(\mathfrak{g}) \times L(\mathfrak{g}) \rightarrow \mathbb{C}$ by

$$
\psi(a, b)=(d(a), b), \quad \forall a, b \in L(\mathfrak{g}) .
$$

It can be shown that $\psi$ is a 2-cocycle on the Lie algebra $L(\mathfrak{g})$, so we can define a central extension

$$
\overline{L(\mathfrak{g})}=L(\mathfrak{g}) \oplus \mathbb{C} c
$$

of $L(\mathfrak{g})$ with bracket

$$
[a+\lambda c, b+\mu c]=[a, b]_{0}+\psi(a, b) c, \quad \forall a, b \in L(\mathfrak{g}), \lambda, \mu \in \mathbb{C}
$$

The centre of $\overline{L(\mathfrak{g})}$ is the 1-dimensional subspace spanned by the element $c$.
It is known that the affine Lie algebra $\overline{L(\mathfrak{g})}$ is isomorphic to the Kac-Moody algebra $\hat{\mathfrak{g}}$ with generalized Cartan matrix $\left(a_{i j}\right)_{i, j \in \hat{I}}$, where $\hat{I}=\{0,1, \ldots, n\}, a_{00}=2$ and

$$
a_{0 i}=-\frac{2\left(\theta, \alpha_{i}\right)}{\left(\alpha_{i}, \alpha_{i}\right)}, \quad a_{i 0}=-\frac{2\left(\theta, \alpha_{i}\right)}{(\theta, \theta)}, \quad \forall i \in I
$$

Thus, $\hat{\mathfrak{g}}$ is given by generators $x_{i}^{ \pm}, h_{i}(i \in \hat{I})$ and the same defining relations as $\mathfrak{g}$, but with $I$ replaced by $\hat{I}$.

### 1.3 Quantum groups

Let $q$ be a transcendental complex number and, for non-zero positive integers $m, n$, $m \leq n$, define

Here, $d_{i}(i \in I)$ are the coprime positive integers such that the matrix $\left(d_{i} a_{i j}\right)_{i, j \in I}$ is symmetric.

The quantum group $U_{q}(\mathfrak{g})$ is the algebra over $\mathbb{C}$ which is generated by elements $x_{i}^{ \pm}, k_{i}^{ \pm 1}(i \in I)$, with the following defining relations:

Then $U_{q}(\mathfrak{g})$ is a Hopf algebra with comultiplication $\Delta$, counit $\epsilon$ and antipode $S$ given by:

\Delta\left(x_{i}^{+}\right)=x_{i}^{+} \otimes k_{i}+1 \otimes x_{i}^{+}, \quad \Delta\left(x_{i}^{-}\right)=x_{i}^{-} \otimes 1+k_{i}^{-1} \otimes x_{i}^{-}, \quad \Delta\left(k_{i}^{ \pm 1}\right)=k_{i}^{ \pm 1} \otimes k_{i}^{ \pm 1}, \\
\epsilon\left(x_{i}^{ \pm}\right)=0, \quad \epsilon\left(k_{i}^{ \pm 1}\right)=1, \\
S\left(x_{i}^{+}\right)=-x_{i}^{+} k_{i}^{-1}, \quad S\left(x_{i}^{-}\right)=-k_{i} x_{i}^{+}, \quad S\left(k_{i}^{ \pm 1}\right)=k_{i}^{\mp 1} .

Let $\hat{\mathfrak{g}}$ be the affine Lie algebra associated to $\mathfrak{g}$. Then, $U_{q}(\hat{\mathfrak{g}})$ is defined to be the algebra over $\mathbb{C}$ which is generated by elements $x_{i}^{ \pm}, k_{i}^{ \pm 1}(i \in \hat{I})$, with defining relations and Hopf algebra structure given by the same formulas as in the $U_{q}(\mathfrak{g})$ case
but with $I$ replaced by $\hat{I}$. Denote by $U_{q}(+)\left(\operatorname{resp} U_{q}(-)\right)$ the subalgebra of $U_{q}(\hat{\mathfrak{g}})$ generated by $k_{i}^{ \pm 1}, x_{i}^{+}$(resp. $\left.k_{i}^{ \pm 1}, x_{i}^{-}\right)(i \in \hat{I})$.

In [1] and [9] there is a realization of $U_{q}(\hat{\mathfrak{g}})$ analogous to the realizations of $\hat{\mathfrak{g}}$ as a central extension of $L(\mathfrak{g})$.

Theorem 1.1. Let $\mathcal{A}_{q}(\mathfrak{g})$ be the algebra over $\mathbb{C}$ with generators $x_{i, r}^{ \pm}(i \in I, r \in \mathbb{Z})$, $k_{i}^{ \pm 1}(i \in I), h_{i, r}(i \in I, r \in \mathbb{Z} /\{0\})$ and $c^{ \pm 1 / 2}$, and the following defining relations:

c^{1 / 2} c^{-1 / 2}=c^{-1 / 2} c^{1 / 2}=1, \quad k_{i} k_{i}^{-1}=k_{i}^{-1} k_{i}=1, \\
k_{i} k_{j}=k_{j} k_{i}, k_{i} h_{j, r}=h_{j, r} k_{i}, \\

In the last relation, $m=1-a_{i j}, \Sigma_{m}$ is the symmetric group on $m$ letters and the $\Phi_{i, r}^{ \pm}$are determined by equating powers of $u$ in the formal power series

the relation is to hold for all sequences of integers $r_{1}, \ldots, r_{m}$.
Then there is an isomorphism of algebras $f: U_{q}(\hat{\mathfrak{g}}) \rightarrow \mathcal{A}_{q}(\mathfrak{g})$ such that

$$
f\left(k_{0}\right)=k_{\theta}^{-1}, f\left(k_{i}\right)=k_{i}, f\left(x_{i}^{ \pm}\right)=x_{i, 0}^{ \pm} .
$$

Here, we have $k_{\theta}=\prod_{i} k_{i}^{r_{i}}$ if $\theta=\sum_{i} r_{i} \alpha_{i}$.

We remark that explicit formulas are known [1] for the images under $f$ of $x_{0}^{ \pm}$, but we shall not need them in this work. On the other hand, explicit expressions are not known for the comultiplication, counit and antipode on the generators $h_{i, s}$ $(i \in I, s \in \mathbb{Z} /\{0\})$. The following result will be sufficient for our purposes.

Lemma 1.2 [11, Lemma 1] On representations of $U_{q}(\hat{\mathfrak{g}})$ on which $c^{1 / 2}$ acts as the identity we have, for all $i \in I, r>0$,

\Delta\left(h_{i, r}\right)=h_{i, r} \otimes 1+1 \otimes h_{i, r}+\text { terms in } U_{+}^{\prime} \otimes U_{-}^{\prime},
$$

where $U_{ \pm}^{\prime}$ is the augmentation ideal of the subalgebra $U_{ \pm}$of $U_{q}(\hat{\mathfrak{g}})$ generated by the elements $x_{j, m}^{ \pm}$for $j \in I, m \in \mathbb{Z}$.

The defining relations of $\mathcal{A}_{q}(\mathfrak{g})$ are clearly $\mathbb{Z}$-graded. Indeed, it is easy to verify that, for any $a \in \mathbb{C}^{*}$, there is a Hopf algebra automorphism $\tau_{a}$ of $U_{q}(\hat{\mathfrak{g}})$ defined by

\tau_{a}\left(x_{i, r}^{ \pm}\right)=a^{r} x_{i, r}^{ \pm}, \quad \tau_{a}\left(\Phi_{i, r}^{ \pm}\right)=a^{r} \Phi_{i, r}^{ \pm}, \\
\tau_{a}\left(c^{1 / 2}\right)=c^{1 / 2}, \quad \tau_{a}\left(k_{i}\right)=k_{i}
\end{gathered}

for all $i \in I, r \in \mathbb{Z}$.

### 1.4 Representation theory: finite case

If $V$ is a representation of $U_{q}(\mathfrak{g})$ then $\lambda \in P$ is a weight of $V$ if the weight space

$$
V_{\lambda}=\left\{v \in V \mid k_{i} \cdot v=q_{i}^{\lambda(i)} v \forall i \in I\right\}
$$

is non-zero. Denote the set of weights of $V$ by $P(V)$. We say that $V$ is of type 1 if

$$
V=\bigoplus_{\lambda \in P(V)} V_{\lambda} .
$$

A vector $v \in V_{\lambda}$ is a highest weight vector if $x_{i}^{+} \cdot v=0 \forall i \in I$. If $V=U_{q}(\mathfrak{g}) \cdot v$, then $V$ is said to be a highest weight representation with highest weight $\lambda$. There is, up to isomorphism, a unique irreducible highest weight representation of any given highest weight $\lambda$, denoted by $V_{q}(\lambda)$.

We shall need the following well-known properties of representations of $U_{q}(\mathfrak{g})$ [7, Section 10.1]:
(a) every finite-dimensional representation of $U_{q}(\mathfrak{g})$ is completely reducible;
(b) every finite-dimensional irreducible representation of $U_{q}(\mathfrak{g})$ of type 1 is highest weight;
(c) the representation $V_{q}(\lambda)$ is finite dimensional if and only if $\lambda \in P^{+}$;
(d) if $\lambda \in P^{+}$, then $V_{q}(\lambda)$ has the same character as the irreducible representation $V(\lambda)$ of $\mathfrak{g}$ of the same highest weight, i.e.

\operatorname{dim} V_{q}(\lambda)_{\mu}=\operatorname{dim} V(\lambda)_{\mu} \quad \forall \mu \in P
$$

(e) the multiplicity $m_{\nu}\left(V_{q}(\lambda) \otimes V_{q}(\mu)\right)$ of $V_{q}(\nu)$ in the tensor product $V_{q}(\lambda) \otimes V_{q}(\mu)$ $\left(\lambda, \mu, \nu \in P^{+}\right)$is the same as in the tensor product of the irreducible representations of $\mathfrak{g}$ of the same highest weights.

### 1.5 Representation theory: affine case

A representation $V$ of $U_{q}(\hat{\mathfrak{g}})$ is said to be of type 1 if $c^{1 / 2}$ acts as the identity on $V$ and if $V$ is of type 1 as a representation of $U_{q}(\mathfrak{g})$. A vector $v \in V$ is an L-highest weight vector if

$$
x_{i, r}^{+} \cdot v=0, \quad \Phi_{i, r}^{ \pm} \cdot v=\phi_{i, r}^{ \pm} v, \quad \forall r \in \mathbb{Z}, i \in I,
$$

for some complex numbers $\phi_{i, r}^{ \pm}$. Note that $\phi_{i, r}^{+}=0$ if $r<0, \phi_{i, r}^{-}=0$ if $r>0$ and $\phi_{i, 0}^{+} \phi_{i, 0}^{-}=1$. A type 1 representation $V$ is said to be an L-highest weight representation if $V=U_{q}(\hat{\mathfrak{g}}) . v$ for some highest weight vector $v$ and the pair of $(I \times \mathbb{Z})$-tuples $\left(\phi_{i, r}^{ \pm}\right)_{i \in I, r \in \mathbb{Z}}$ is said to be its L-highest weight.

Let $\mathcal{P}$ be the set of all $I$-tuples $\left(P_{i}\right)_{i \in I}$ of polynomials $P_{i} \in \mathbb{C}[u]$ with constant term 1.

Theorem 1.3 [6, Theorem 3.3]

1) Every finite-dimensional irreducible representation of $U_{q}(\hat{\mathfrak{g}})$ of type 1 is $L$ highest weight.
2) The irreducible representation $V$ of $U_{q}(\hat{\mathfrak{g}})$ of type 1 and L-highest weight $\left(\phi_{i, r}^{ \pm}\right)_{i \in I, r \in \mathbb{Z}}$ is finite dimensional iff there exists $\mathbf{P}=\left(P_{i}\right)_{i \in I} \in \mathcal{P}$ such that

\sum_{r=0}^{\infty} \phi_{i, \pm r}^{ \pm} u^{ \pm r}=q_{i}^{\operatorname{deg}\left(P_{i}\right)} \frac{P_{i}\left(q_{i}^{-2} u\right)}{P_{i}(u)}
$$

as an element of $\mathbb{C}\left[\left[u^{ \pm 1}\right]\right]$.

We denote the finite-dimensional irreducible representation of $U_{q}(\hat{\mathfrak{g}})$ associated to $\mathbf{P}$ by $V(\mathbf{P})$ and call $\mathbf{P}$ its highest weight, by abuse of notation. The highest weight of $V(\mathbf{P})$ considered as a $U_{q}(\mathfrak{g})$-module is

$$
\lambda=\sum_{i \in I}\left(\operatorname{deg} P_{i}\right) \lambda_{i} .
$$

Proposition 1.4 [6, Corollary 3.5] If $\mathbf{P}=\left(P_{i}\right)_{i \in I}$ and $\mathbf{Q}=\left(Q_{i}\right)_{i \in I}$ are members of $\mathcal{P}$, denote by $\mathbf{P} \otimes \mathbf{Q} \in \mathcal{P}$ the I-tuple $\left(P_{i} Q_{i}\right)_{i \in I}$. Then $V(\mathbf{P} \otimes \mathbf{Q})$ is isomorphic, as a representation of $U_{q}(\hat{\mathfrak{g}})$, to a quotient of the subrepresentaion of $V(\mathbf{P}) \otimes V(\mathbf{Q})$
generated by the tensor product of the L-highest weight vectors in $V(\mathbf{P})$ and $V(\mathbf{Q})$.

Since every polynomial is a product of linear polynomials, we define a representation $V(\mathbf{P})$ of $U_{q}(\hat{\mathfrak{g}})$ to be fundamental if, for some $i \in I$,

$$
P_{j}=1 \quad \text { if } j \neq i, \quad \operatorname{deg}\left(P_{i}\right)=1
$$

With this definition, we have the following corollary of Proposition 1.4:

Corollary 1.5 [6, Corollary 3.6] For any $\mathbf{P} \in \mathcal{P}$, the representation $V(\mathbf{P})$ of $U_{q}(\hat{\mathfrak{g}})$ is isomorphic to a subquotient of a tensor product of fundamental representations.

The left dual ${ }^{t} V(\mathbf{P})$ of $V(\mathbf{P})$ is the representation of $U_{q}(\hat{\mathfrak{g}})$ on the vector space dual of $V(\mathbf{P})$ given by

$$
\langle a . f, v\rangle=\langle f, S(a) . v\rangle, \quad \forall a \in U_{q}(\hat{\mathfrak{g}}), v \in V(\mathbf{P}), f \in{ }^{t} V(\mathbf{P}),
$$

where $S$ is the antipode of $U_{q}(\hat{\mathfrak{g}})$ and $\langle$,$\rangle is the natural pairing between V(\mathbf{P})$ and its dual. The right dual $V(\mathbf{P})^{t}$ is defined in the same way, but replacing $S$ by $S^{-1}$.

Lemma 1.6 [4, Lemma 6.2] If $\mathfrak{g}$ is of type $C_{2}$, with $\alpha_{1}$ being the short root, then for any $a \neq 0$,

$$
V(1,1-u a q)^{t} \cong V\left(1,1-u a q^{-6}\right), \quad{ }^{t} V(1,1-u a q) \cong V\left(1,1-u a q^{6}\right)
$$

The following result is easy to check.

Lemma 1.7 For any $\mathbf{P} \in \mathcal{P}, a \in \mathbb{C}^{*}$, let $\tau_{a}^{*}(V(\mathbf{P}))$ be the pull-back of $V(\mathbf{P})$ by the automorphism $\tau_{a}$. Then,

$$
\tau_{a}^{*}(V(\mathbf{P})) \cong V\left(\mathbf{P}^{a}\right)
$$

where $\mathbf{P}^{a}=\left(P_{i}^{a}\right)_{i \in I}$ and $P_{i}^{a}(u)=P_{i}(a u)$.

### 1.6 Minimal affinizations

Let $\mathbf{P}=\left(P_{i}\right)_{i \in I} \in \mathcal{P}$, and let $0 \neq v_{\mathbf{P}}$ be an L-highest weight vector in $V(\mathbf{P})$. If $\lambda \in P^{+}$is defined by

$$
\lambda(i)=\operatorname{deg}\left(P_{i}\right) \quad \forall i \in I,
$$

then

$$
k_{i} \cdot v_{\mathbf{P}}=q_{i}^{\lambda(i)} v_{\mathbf{P}}
$$

so

$$
V(\mathbf{P})_{\lambda}=\mathbb{C} v_{\mathbf{P}} \quad \text { and } \quad V(\mathbf{P})=\bigoplus_{\nu \in Q^{+}} V(\mathbf{P})_{\lambda-\nu}
$$

Since $V(\mathbf{P})$ is finite dimensional it is completely reducible as a representation of $U_{q}(\mathfrak{g})$. Hence,

$$
V(\mathbf{P}) \cong V_{q}(\lambda) \oplus \bigoplus_{\mu \in P^{+}} V_{q}(\mu)^{\oplus_{m}}
$$

as a representation of $U_{q}(\mathfrak{g})$, where the multiplicities $m_{\mu} \in \mathbb{N}$ are zero unless $\mu<\lambda$.
Thus, $V(\mathbf{P})$ gives a way of extending the action of $U_{q}(\mathfrak{g})$ on $V_{q}(\lambda)$ to an action of $U_{q}(\hat{\mathfrak{g}})$, by enlarging $V_{q}(\lambda)$ by the addition of representations of $U_{q}(\mathfrak{g})$ of smaller highest weight. For this reason, $V(\mathbf{P})$ is called an affinization of $\lambda$, or of $V_{q}(\lambda)$. Two affinizations of $\lambda$ are said to be equivalent if they are isomorphic as representations of $U_{q}(\mathfrak{g})$. If $V$ is an affinization of $\lambda \in P^{+}$, its equivalence class is denoted by [ $V$ ] and we write $A^{\lambda}$ for the set of equivalence classes of affinizations of $\lambda$.

We define a partial ordering on the set of equivalence classes of affinizations as follows. If $\lambda \in P^{+},[V],[W] \in A^{\lambda}$, then $[V] \leq[W]$ if and only if, for all $\mu \in P^{+}$, either

$$
m_{\mu}(V) \leq m_{\mu}(W)
$$

or
there exists $\nu \geq \mu$ with $m_{\nu}(V)<m_{\nu}(W)$.
An affinization $V$ of $\lambda$ is minimal if $[V]$ is a minimal element of $A^{\lambda}$ for the partial order defined above, i.e. if $[W] \in A^{\lambda}$ and $[W] \leq[V]$ implies $[V]=[W]$.

To state the main general result about minimal affinizations we shall use, we need one more definition. Namely, the $q$-segment of centre $a \in \mathbb{C}^{*}$ and length $r \in \mathbb{N}$ is defined to be the $r$-tuple of complex numbers

$$
\left(a q^{-r+1}, a q^{-r+3}, \ldots, a q^{r-1}\right) .
$$

Two $q$-segments are said to be in special position if their union is a $q$-segment that properly contains both of them; they are said to be in general position otherwise. It
is an elementary combinatorial fact that, if $S$ is any finite set of non-zero complex number with multiplicities; then $S$ can be written uniquely as the union of $q$ segments $S_{1}, \ldots, S_{N}$, any two of which are in general position.

In the case $\mathfrak{g}=s l_{2}(\mathbb{C})$, it is known $([7$, Section 12.2]) that $V(P)$ is a minimal affinization if and only if the roots of the polynomial $P$ form a $q$-segment, and that $V(P)$ is then irreducible as a $U_{q}(\mathfrak{g})$-module. The situation in rank 2 is as follows:

Proposition 1.8 [2, Theorem 5.1] Let $\mathfrak{g}$ be of rank 2, $r_{1}, r_{2} \geq 0$ and $\lambda=r_{1} \lambda_{1}+$ $r_{2} \lambda_{2} \in P^{+}$. Then, $A^{\lambda}$ has a unique minimal element. This element is represented by $V(\mathbf{P})(\mathbf{P} \in \mathcal{P})$ if and only if the following two conditions are satisfied:
(a) for all $i=1,2$, either $P_{i}=1$ or the roots of $P_{i}$ form a $q_{i}$-segment with center $a_{i}$ and length $r_{i}$, say, and
(b) if $P_{1} \neq 1$ and $P_{2} \neq 1$, then

$$
\frac{a_{1}}{a_{2}}=q^{d_{1} r_{1}+d_{2} r_{2}+2 d_{2}-1} \quad \text { or } \quad \frac{a_{1}}{a_{2}}=q^{-\left(d_{1} r_{1}+d_{2} r_{2}+2 d_{1}-1\right)}
$$

The following results describe the structure of minimal affinizations of $U_{q}(\mathfrak{g})$-modules when $\mathfrak{g}$ is of type $A_{2}$ or $C_{2}$.

Proposition 1.9 [5, Section 3] Let $\mathfrak{g}$ be of type $A_{2}, \lambda \in P^{+}$and let $V(\mathbf{P})$ be a minimal affinization of $\lambda$. Then, $V(\mathbf{P}) \cong V_{q}(\lambda)$ as a representation of $U_{q}(\mathfrak{g})$.

For any real number $b$, int $b$ denotes the greatest integer less than or equal to $b$.

Proposition 1.10 [2, Theorem 6.1] Let $\mathfrak{g}$ be of type $C_{2}, \lambda \in P^{+}$and let $V(\mathbf{P})$ be a minimal affinization of $\lambda$. Then, as a representation of $U_{q}(\mathfrak{g})$,

$$
V(\mathbf{P}) \cong \bigoplus_{r=0}^{i n t\left(\frac{1}{2} \lambda(2)\right)} V_{q}\left(\lambda-2 r \lambda_{2}\right)
$$

In the $G_{2}$ case we have less complete information.

Proposition 1.11 Let $\mathfrak{g}$ be of type $G_{2}$ and let $m \in \mathbb{N}$. Let $V(\mathbf{P})($ resp. $V(\mathbf{Q}))$ be a minimal affinization of $m \lambda_{1}$ (resp. $\lambda_{2}$ ). Then, as $U_{q}(\mathfrak{g})$-modules,

$$
V(\mathbf{P}) \cong \bigoplus_{k=0}^{m} V_{q}\left(k \lambda_{1}\right), \quad V(\mathbf{Q}) \cong V_{q}\left(\lambda_{2}\right)
$$

(The nodes of the Dynkin diagram of $\mathfrak{g}$ are numbered so that $\alpha_{1}$ is the long root).
Proof. See [3, p. 645] and [2, p. 125].

### 1.7 Quantum characters

Many basic questions remain unanswered about the structure of the finite dimensional representations of quantum affine algebras. A useful tool for studying these questions is the theory of $q$-characters developed in [10], [11].

Recall that if $V$ is a finite-dimensional $U_{q}(\mathfrak{g})$-module, its character is the element of the ring $\mathbb{Z}\left[y_{i}^{ \pm 1}\right]_{i \in I}$ defined by

$$
\chi(V)=\sum_{\lambda \in P(V)} \operatorname{dim} V_{\lambda} \prod_{i \in I} y_{i}^{\lambda(i)}
$$

If Rep $A$ denotes the Grothendieck ring of finite-dimensional modules for an algebra $A$ over $\mathbb{C}$, then $\chi$ defines a ring homomorphism

$$
\chi: \operatorname{Rep} U_{q}(\mathfrak{g}) \rightarrow \mathbb{Z}\left[y_{i}^{ \pm 1}\right]_{i \in I} .
$$

Turning now to the $U_{q}(\hat{\mathfrak{g}})$ case, note that it follows from the defining relations of $U_{q}(\hat{\mathfrak{g}})$ that the $\Phi_{i, r}^{ \pm}(i \in I, r \in \mathbb{Z})$ commute with each other on any finitedimensional $U_{q}(\hat{\mathfrak{g}})$-module $V$ of type 1 . Hence, $V$ can be decomposed into generalized eigenspaces

$$
V=\bigoplus V_{\left(\gamma_{i, r}\right)}
$$

indexed by families $\gamma=\left(\gamma_{i, r}^{ \pm}\right)$of complex numbers, where

$$
V_{\left(\gamma_{i, r}\right)}=\left\{v \in V \mid \forall i \in I, r \in \mathbb{Z}, \exists p \in \mathbb{N} \text { such that }\left(\Phi_{i, r}^{ \pm}-\gamma_{i, r}^{ \pm}\right)^{p} . v=0\right\}
$$

Given such a family $\gamma$, form the generating functions $\gamma_{i}^{ \pm}(u)=\sum_{r=1}^{\infty} \gamma_{i, \pm r}^{ \pm} u^{ \pm r}$. By [11, Proposition 1], the $\gamma_{i}^{ \pm}(u)$ have the form

$$
\gamma_{i}^{ \pm}(u)=q_{i}^{\operatorname{deg} Q_{i}-\operatorname{deg} R_{i}} \frac{Q_{i}\left(q_{i}^{-1} u^{-1}\right) R_{i}\left(q_{i} u^{-1}\right)}{Q_{i}\left(q_{i} u^{-1}\right) R_{i}\left(q_{i}^{-1} u\right)}
$$

where $Q_{i}, R_{i}(i \in I)$ are polynomials in $u$ with constant term 1 . Write

$$
Q_{i}(u)=\prod_{r=1}^{m_{i}}\left(1-a_{r} u\right), \quad R_{i}(u)=\prod_{s=1}^{n_{i}}\left(1-b_{s} u\right)
$$

Definition 1.12 Let $Y_{i, a}$, for $i \in I, a \in \mathbb{C}^{*}$, be invertible indeterminates. With the above notation, the $q$-character $\chi_{q}(V)$ is the element of the ring $\mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in I, a \in \mathbb{C}^{*}}$ given by

$$
\chi_{q}(V)=\sum_{\gamma} \operatorname{dim} V_{\gamma} \prod_{i \in I} \prod_{r=1}^{m_{i}} Y_{i, a_{r}} \prod_{s=1}^{n_{i}} Y_{i, b_{s}}^{-1} .
$$

Assign the weight $\lambda_{i}$ to $Y_{i, a}$, and compute the weight of a monomial

$$
\prod_{i \in I} \prod_{r=1}^{m_{i}} Y_{i, a_{r}} \prod_{s=1}^{n_{i}} Y_{i, b_{s}}^{-1}
$$

by adding the weights of the factors. Such a monomial is said to be dominant if $n_{i}=0$ for all $i \in I$.

To state the main results about $\chi_{q}$ we shall need, denote by

$$
\beta: \mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in I, a \in \mathbb{C}^{*}} \rightarrow \mathbb{Z}\left[y_{i}^{ \pm 1}\right]_{i \in I}
$$

the ring homomorphism taking $Y_{i, a}$ to $y_{i}$ for all $i \in I, a \in \mathbb{C}^{*}$, and by

$$
\text { res }: \operatorname{Rep} U_{q}(\hat{\mathfrak{g}}) \rightarrow \operatorname{Rep} U_{q}(\mathfrak{g})
$$

the restriction homomorphism. More generally, given $J \subset I$, denote by $U_{q}(\mathfrak{g})_{J}$ the subalgebra of $U_{q}(\mathfrak{g})$ generated by the $k_{i}^{ \pm 1}, x_{i}^{ \pm}$for $i \in J$, and by $U_{q}(\hat{\mathfrak{g}})_{J}$ the subalgebra of $U_{q}(\hat{\mathfrak{g}})$ generated by $k_{i}^{ \pm 1}, h_{i, r}, x_{i, r}^{ \pm}$for $i \in J, r \in \mathbb{Z}$. Let

$$
\beta_{J}: \mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in I, a \in \mathbb{C}^{*}} \rightarrow \mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in I, a \in \mathbb{C}^{*}}
$$

be the homomorphism such that $\beta_{J}\left(Y_{i, a}\right)=Y_{i, a}$ if $i \in J$, and $\beta_{J}\left(Y_{i, a}\right)=1$ if $i \notin J$; let $\operatorname{res}_{J}: U_{q}(\hat{\mathfrak{g}})_{J} \rightarrow U_{q}(\mathfrak{g})_{J}$ be the restriction homomorphism; and define

$$
\chi_{q, J}: \operatorname{Rep} U_{q}(\hat{\mathfrak{g}})_{J} \rightarrow \mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in J, a \in \mathbb{C}^{*}}
$$

in the obvious way.

Theorem 1.13 [11, Theorem 3]

1) $\chi_{q}$ defines an injective homomorphism

$$
\chi_{q}: \operatorname{Rep} U_{q}(\hat{\mathfrak{g}}) \rightarrow \mathbb{Z}\left[Y_{i, a}^{ \pm 1}\right]_{i \in I, a \in \mathbb{C}^{*}}
$$

2) The diagram

commutes.
3) For any $J \subset I$, the diagram

commutes.
In [11] the $q$-characters of the first fundamental representation (with standard numbering) are given. From these examples, and using the non-trivial diagram automorphism of $A_{2}$, we have in the type $A_{2}$ case:

$$
\begin{gathered}
\chi_{q}(V(1-a q u, 0))=Y_{1, a q}+Y_{2, a q^{2}} Y_{1, a q^{3}}^{-1}+Y_{2, a q^{4}}^{-1} \\
\chi_{q}(V(0,1-a q u))=Y_{2, a}+Y_{1, a q} Y_{2, a q^{2}}^{-1}+Y_{1, a q^{3}}^{-1}
\end{gathered}
$$

Similarly, making use of the natural isomorphism between types $B_{2}$ and $C_{2}$, we have in type $C_{2}$ :

$$
\begin{gathered}
\chi_{q}(V(1-a q u, 0))=Y_{1, a}+Y_{2, a q} Y_{2, a q^{3}} Y_{1, a q^{4}}^{-1}+Y_{2, a q} Y_{2, a q^{5}}^{-1}+Y_{1, a q^{2}} Y_{2, a q^{3}}^{-1} Y_{2, a q^{5}}^{-1}+Y_{1, a q^{7}}^{-1}, \\
\chi_{q}(V(0,1-a q u))=Y_{2, a}+Y_{2, a q^{4}} Y_{1, a q^{5}}^{-1}+Y_{1, a q} Y_{2, a q^{2}}^{-1}+Y_{2, a q^{6}}^{-1} .
\end{gathered}
$$

These special cases will be used extensively in the following chapters.

## 2. Computations: the $\mathrm{A}_{2}$ case

In this section, $\mathfrak{g}$ is of type $A_{2}$. We denote by $V_{a}(m, n)$ the minimal affinization of $m \lambda_{1}+n \lambda_{2}$ in which the inverse roots of the polynomial $P_{2}$ form a $q$-segment with centre $a$ (if $n=0$ the parameter $a$ will denote the centre of the inverse roots of $P_{1}$ ).

### 2.1 Computation of $W_{a q}(0, n)$

Proposition 2.1 There exists an exact sequence of $U_{q}(\hat{\mathfrak{g}})$-modules

$$
\left.\begin{array}{rl}
0 \rightarrow V_{a q^{-3}}(0, n-3) \rightarrow & V_{a q^{-2}}(0, n-2)
\end{array}\right) V_{a q^{n-2}}(1,0) .
$$

Proof. By Proposition 1.8, $V_{a}(0, n)$ has polynomials

$$
P_{1}(u)=1, \quad P_{2}(u)=\prod_{j=1}^{n}\left(1-u a q^{-n-1+2 j}\right)
$$

From Proposition 1.4, $V_{a}(0, n)$ is a quotient of $V_{c}(0, n-1) \otimes V_{b}(0,1)$ for some $b, c \in C^{*}$. For this to happen the polynomials of $V_{c}(0, n-1), V_{b}(0,1)$ must multiply to $P_{1}$ and $P_{2}$. Now $V_{c}(0, n-1)$ has polynomials

$$
Q_{1}(u)=1, \quad Q_{2}(u)=\prod_{j=1}^{n-1}\left(1-u c q^{-n+2 j}\right)
$$

and $V_{b}(0,1)$ has polynomials

$$
R_{1}(u)=1, \quad R_{2}(u)=1-u b
$$

So we must have $R_{1} Q_{1}=P_{1}$, which happens automatically, and $R_{2} Q_{2}=P_{2}$. It is necessary to set $b=a q^{n-1}, c=a q^{-1}$, and so

$$
R_{2}(u)=1-u a q^{n-1}
$$

Consider now the kernel $K_{1}$ of the quotient map $V_{c}(0, n-1) \otimes V_{b}(0,1) \rightarrow V_{a}(0, n)$. As $U_{q}(\mathfrak{g})$-modules,

$$
V_{c}(0, n-1) \cong V_{q}\left((n-1) \lambda_{2}\right), V_{b}(0,1) \cong V_{q}\left(\lambda_{2}\right), V_{a}(0, n) \cong V_{q}\left(n \lambda_{2}\right)
$$

Now,

$$
V_{q}\left((n-1) \lambda_{2}\right) \otimes V_{q}\left(\lambda_{2}\right) \cong V_{q}\left(n \lambda_{2}\right) \oplus V_{q}\left(\lambda_{1}+(n-2) \lambda_{2}\right)
$$

So $K_{1} \cong V_{q}\left(\lambda_{1}+(n-2) \lambda_{2}\right)$ as a $U_{q}(\mathfrak{g})$-module; in particular, $K_{1}$ is irreducible as a $U_{q}(\hat{\mathfrak{g}})$-module. Now, for any $L$-highest weight vector $u$ in a $U_{q}(\hat{\mathfrak{g}})$-module, and any $i \in I, k \in \mathbb{Z}, x_{i, k}^{-} \cdot u$ is a scalar multiple of $x_{i}^{-} \cdot u$. It follows that $K_{1}$ is spanned by the vectors

$$
x_{2}^{-} \cdot v \otimes w, v \otimes x_{2}^{-} . w
$$

with $v$ highest weight in $V_{c}(0, n-1)$ and $w$ highest weight in $V_{b}(0,1)$. Thus, any non-zero L-highest weight vector $z \in K_{1}$ is of the form

$$
z=A x_{2}^{-} \cdot v \otimes w+B v \otimes x_{2}^{-} \cdot w
$$

for some $A, B \in \mathbb{C}$. Since $K_{1}$ is irreducible as a $U_{q}(\hat{\mathfrak{g}})$-module, it is generated by $z$ as a $U_{q}(\hat{\mathfrak{g}})$-module. Using Lemma 1.2, for any $k>0$,

$$
\begin{aligned}
h_{i, k} \cdot z & =\Delta\left(h_{i, k}\right) \cdot z \\
& =A\left(h_{i, k} x_{2}^{-} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{i, k} \cdot w+\text { a term in } U_{+}^{\prime} x_{2}^{-} \cdot v \otimes U_{-}^{\prime} \cdot w\right) \\
& +B\left(h_{i, k} \cdot v \otimes x_{2}^{-} \cdot w+v \otimes h_{i, k} x_{2}^{-} \cdot w+\mathrm{a} \text { term in } U_{+}^{\prime} \cdot v \otimes U_{-}^{\prime} x_{2}^{-} \cdot w\right)
\end{aligned}
$$

Since $v$ is L-highest weight, it follows that $U_{+}^{\prime} . v \otimes U_{-}^{\prime} x_{2}^{-} . w$ is zero and $U_{+}^{\prime} x_{2}^{-} . v \otimes U_{-}^{\prime} . w$ is a scalar multiple of $v \otimes x_{2}^{-} . w$. So

$$
h_{i, k} . z=A\left(h_{i, k} x_{2}^{-} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{i, k} \cdot w\right)+\text { scalar multiples of } v \otimes x_{2}^{-} \cdot w .
$$

Since we know that $z$ is an eigenvector of $h_{i, k}$, it follows that to calculate $h_{i, k} . z$ it suffices to calculate $h_{i, k} x_{2}^{-} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{i, k} . w$.

Using the relations from Theorem 1.1, we have

$$
\begin{align*}
h_{i, k} \cdot z & =A\left(h_{i, k} x_{2}^{-} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{i, k} \cdot w\right) \\
& =A\left(-\frac{1}{k}\left[k a_{i, 2}\right]_{q} x_{2, k}^{-} \cdot v \otimes w+x_{2}^{-} h_{i, k} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{i, k} \cdot w\right) . \tag{1}
\end{align*}
$$

To calculate this it is necessary to use Theorems 1.1 and 1.3 , which give

$$
\sum_{k=1}^{\infty} u^{k} h_{i, k} \cdot v=\frac{1}{q-q^{-1}} \log \left(\frac{Q_{i}\left(q^{-2} u\right)}{Q_{i}(u)}\right) v
$$

Since $Q_{1}(u)=1=R_{1}(u)$, this gives $h_{1, k} \cdot v=0$ and $h_{1, k} \cdot w=0$. Now

$$
\frac{Q_{2}\left(u q^{-2}\right)}{Q_{2}(u)}=\frac{1-u a q^{-n-1}}{1-u a q^{n-3}}
$$

so

$$
\begin{aligned}
\sum_{k=1}^{\infty} u^{k} h_{2, k} \cdot v & =\frac{1}{q-q^{-1}} \log \left(\frac{1-u a q^{-n-1}}{1-u a q^{n-3}}\right) v \\
& =\frac{1}{q-q^{-1}}\left(\log \left(1-u a q^{-n-1}\right)-\log \left(1-u a q^{n-3}\right)\right) v .
\end{aligned}
$$

Hence, comparing coefficients of $u^{k}$,

$$
\begin{equation*}
h_{2, k} . v=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-3)}-q^{-k(n+1)}\right) v . \tag{2}
\end{equation*}
$$

Using the fact that

$$
\frac{R_{2}\left(u q^{-2}\right)}{R_{2}(u)}=\frac{1-u a q^{n-3}}{1-u a q^{n-1}},
$$

similar calculations give

$$
h_{2, k} \cdot w=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-1)}-q^{k(n-3)}\right) w .
$$

We must now calculate the term $x_{2, k}^{-} \cdot v$. For some $C_{k} \in \mathbb{C}(k>0)$, we have

$$
x_{2, k}^{-} \cdot v=C_{k} x_{2}^{-} . v .
$$

Applying $x_{2}^{+}$gives

$$
\frac{\Phi_{2, k}^{+}}{q-q^{-1}} \cdot v=C_{k} \frac{q^{n-1}-q^{-n+1}}{q-q^{-1}} v .
$$

By Theorem 1.3,

$$
\begin{aligned}
\sum_{k=0}^{\infty} u^{k} \Phi_{2, k}^{+} v & =q^{\operatorname{deg}_{Q_{2}} \frac{Q_{2}\left(u q^{-2}\right)}{Q_{2}(u)} v} \\
& =q^{n-1}\left(1-u a q^{-n-1}\right)\left(1-u a q^{n-3}\right)^{-1} v
\end{aligned}
$$

and comparing coefficients of $u^{k}$ we get

$$
\Phi_{2, k}^{+} \cdot v=a^{k} q^{k(n+1)}\left(q^{n-1}-q^{-n+1}\right) v
$$

so

$$
\frac{a^{k} q^{k(n+1)}\left(q^{n-1}-q^{-n+1}\right)}{\left(q-q^{-1}\right)} v=C_{k} \frac{q^{n-1}-q^{-n+1}}{q-q^{-1}} v
$$

hence

$$
C_{k}=a^{k} q^{k(n-3)}
$$

Finally, we have

$$
x_{2, k}^{-} \cdot v=a^{k} q^{k(n-3)} x_{2}^{-} \cdot v .
$$

Now, for $i=1$ the term in braces on the right-hand side of equation (1) becomes

$$
\frac{[k]_{q}}{k} x_{2, k}^{-} \cdot v \otimes w+x_{2}^{-} h_{1, k} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{1, k} \cdot w
$$

so

$$
h_{1, k} . z=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-2)}-q^{k(n-4)}\right) z,
$$

while for $i=2$ it becomes

$$
-\frac{[2 k]_{q}}{k} x_{2, k}^{-} \cdot v \otimes w+x_{2}^{-} h_{2, k} \cdot v \otimes w+x_{2}^{-} \cdot v \otimes h_{2, k} \cdot w
$$

so

$$
\begin{aligned}
h_{2, k} . z & =\frac{a^{k}}{k}\left(q^{k(n-5)}-q^{k(n-1)}+q^{k(n-1)}-q^{k(n-3)}+q^{k(n-3)}-q^{-k(n+1)}\right) z \\
& =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-5)}-q^{-k(n+1)}\right) z
\end{aligned}
$$

These expressions for $h_{1, k} . z$ and $h_{2, k} . z$ are enough to determine the defining polynomials $S_{1}, S_{2}$ of $K_{1}$ via

$$
\sum_{k=1}^{\infty} u^{k} h_{i, k} . z=\frac{1}{q-q^{-1}} \log \left(\frac{S_{i}\left(q^{-2} u\right)}{S_{i}(u)}\right) z
$$

This gives

$$
S_{1}(u)=1-u a q^{n-2}, \quad S_{2}(u)=\prod_{j=1}^{n-2}\left(1-u a q^{-n-1+2 j}\right),
$$

and we have an exact sequence

$$
0 \rightarrow V\left(S_{1}, S_{2}\right) \rightarrow V_{a q^{-1}}(0, n-1) \otimes V_{a q^{n-1}}(0,1) \rightarrow V_{a}(0, n) \rightarrow 0
$$

The next step is to get $K_{1}$ as a quotient of the tensor product of evaluation representations

$$
V_{d}(1,0) \otimes V_{e}(0, n-2) .
$$

Now, $V_{d}(1,0)$ has polynomials

$$
Q_{1}(u)=1-u d, \quad Q_{2}(u)=1
$$

and $V_{e}(0, n-1)$ has polynomials

$$
R_{1}(u)=1, \quad R_{2}(u)=\prod_{j=1}^{n-2}\left(1-u e q^{-n+1+2 j}\right)
$$

so by Proposition 1.4, for $K_{1}$ to be in the quotient of this tensor product we must have $S_{1}=R_{1} Q_{1}, S_{2}=R_{2} Q_{2}$, which gives $d=a q^{n-2}$ and $e=a q^{-2}$. Thus, we have an exact sequence

$$
\begin{equation*}
0 \rightarrow K_{2} \rightarrow V_{a q^{n-2}}(1,0) \otimes V_{a q^{-2}}(0, n-2) \rightarrow K_{1} \rightarrow 0 \tag{3}
\end{equation*}
$$

say.
Let $v^{\prime} \neq 0$ be an L-highest weight vector in $V_{a q^{-2}}(0, n-2)$ and $w^{\prime} \neq 0$ an Lhighest weight vector in $V_{a q^{n-2}}(1,0)$. Using the $U_{q}(\mathfrak{g})$-structure of these modules and the fact that

$$
x_{1}^{-} \cdot v^{\prime}=x_{2}^{-} \cdot w^{\prime}=0
$$

an L-highest weight vector in $K_{2}$ must have the form

$$
z^{\prime}=A^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+B^{\prime} v^{\prime} \otimes x_{2}^{-} x_{1}^{-} \cdot w^{\prime}+C^{\prime} x_{2}^{-} \cdot v^{\prime} \otimes x_{1}^{-} \cdot w^{\prime}
$$

for some $A^{\prime}, B^{\prime}, C^{\prime} \in \mathbb{C}$. As in the proof of Proposition 2.7 below, one sees that $K_{2}$ is generated by $z^{\prime}$ as a $U_{q}(\hat{\mathfrak{g}})$-module. Let the L-highest weight of $z^{\prime}$ be given by the polynomials $T_{1}, T_{2}$. Then,

$$
\begin{aligned}
h_{i, k} \cdot z^{\prime} & =\Delta\left(h_{i, k}\right) \cdot z^{\prime} \\
& =A^{\prime}\left(h_{i, k} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{i, k} \cdot w^{\prime}+\mathrm{a} \text { term in } U_{+}^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes U_{-}^{\prime} \cdot w^{\prime}\right) \\
& +B^{\prime}\left(h_{i, k} \cdot v^{\prime} \otimes x_{2}^{-} x_{1}^{-} \cdot w^{\prime}+v^{\prime} \otimes h_{i, k} x_{2}^{-} x_{1}^{-} \cdot w^{\prime}\right) \\
& +C^{\prime}\left(h_{i, k} x_{2}^{-} \cdot v^{\prime} \otimes x_{1}^{-} \cdot w^{\prime}+x_{2}^{-} \cdot v^{\prime} \otimes h_{i, k} x_{1}^{-} \cdot w^{\prime}+\text { a term in } U_{+}^{\prime} x_{2}^{-} \cdot v^{\prime} \otimes U_{-}^{\prime} x_{1}^{-} \cdot w^{\prime}\right) .
\end{aligned}
$$

Note that $U_{+}^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes U_{-}^{\prime} . w^{\prime}$ gives unknown scalar multiples of $x_{2}^{-} \cdot v^{\prime} \otimes x_{1}^{-} \cdot w^{\prime}$ and $v^{\prime} \otimes x_{2}^{-} x_{1}^{-} \cdot w^{\prime}$, and $U_{+}^{\prime} x_{2}^{-} \cdot v^{\prime} \otimes U_{-}^{\prime} x_{1}^{-} \cdot w^{\prime}$ gives unknown scalar multiples of $v^{\prime} \otimes$ $x_{2}^{-} x_{1}^{-} \cdot w^{\prime}$. Hence, to calculate $h_{i, k} \cdot z^{\prime}$ we consider the terms involving $x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}$. Hence, we must calculate

$$
\begin{equation*}
h_{i, k} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{i, k} \cdot w^{\prime} . \tag{4}
\end{equation*}
$$

Now,

$$
\begin{aligned}
& \frac{Q_{1}\left(q^{-2} u\right)}{Q_{1}(u)}=\frac{1-u a q^{n-4}}{1-u a q^{n-2}}, \quad \frac{Q_{2}\left(q^{-2} u\right)}{Q_{2}(u)}=1, \\
& \frac{R_{1}\left(q^{-2} u\right)}{R_{1}(u)}=1, \quad \frac{R_{2}\left(q^{-2} u\right)}{R_{2}(u)}=\frac{1-u a q^{-n-1}}{1-u a q^{n-5}}
\end{aligned}
$$

which gives

$$
\begin{aligned}
& h_{1, k} \cdot v^{\prime}=0, \quad h_{1, k} \cdot w^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-2)}-q^{k(n-4)}\right) w^{\prime}, \\
& h_{2, k} \cdot v^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-5)}-q^{k(-n-1)}\right) v^{\prime}, \quad h_{2, k} \cdot w^{\prime}=0, \\
& x_{2, k}^{-} \cdot v^{\prime}=a^{k} q^{k(n-5)} x_{2}^{-} \cdot v^{\prime}, \quad x_{1, k}^{-} \cdot w^{\prime}=a^{k} q^{k(n-2)} x_{1}^{-} \cdot w^{\prime} .
\end{aligned}
$$

To calculate (4), it is also necessary to find an expression for $x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}$. For some $D_{k}^{\prime} \in \mathbb{C}$,

$$
x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}=D_{k}^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime}
$$

Applying $x_{1}^{+}$gives

$$
\frac{\Phi_{1, k}^{+}}{q-q^{-1}} x_{2}^{-} \cdot v^{\prime}=D_{k}^{\prime} x_{2}^{-} \cdot v^{\prime}
$$

By Theorem 3.1,

$$
\begin{aligned}
\sum_{k=0}^{\infty} u^{k} \Phi_{1, k}^{+} x_{2}^{-} \cdot v^{\prime} & =k_{1} \exp \left(\left(q-q^{-1}\right) \sum_{s=1}^{\infty} h_{1, s} u^{s}\right) x_{2}^{-} \cdot v^{\prime} \\
& =q \exp \left(\sum_{s=1}^{\infty} \frac{u^{s} a^{s}}{s}\left(q^{s(n-4)}-q^{s(n-6)}\right)\right) x_{2}^{-} \cdot v^{\prime} \\
& =q \frac{\left(1-a u q^{n-6}\right)}{\left(1-a u q^{n-4}\right)} x_{2}^{-} \cdot v^{\prime}
\end{aligned}
$$

so

$$
\Phi_{1, k}^{+} x_{2}^{-} \cdot v^{\prime}=a^{k} q^{k(n-4)}\left(q-q^{-1}\right) x_{2}^{-} \cdot v^{\prime} .
$$

This gives $D_{k}^{\prime}=a^{k} q^{k(n-4)}$, and hence

$$
x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}=a^{k} q^{k(n-4)} x_{1}^{-} x_{2}^{-} \cdot v^{\prime}
$$

For $i=1$, (4) now becomes

$$
-\frac{[2 k]_{q}}{k} x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} h_{1, k} \cdot v^{\prime} \otimes w^{\prime}+\frac{[k]_{q}}{k} x_{1}^{-} x_{2, k}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{1, k} \cdot w^{\prime}
$$

which gives

$$
\begin{aligned}
h_{1, k} . z^{\prime} & =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-6)}-q^{k(n-2)}+q^{k(n-4)}-q^{k(n-6)}+q^{k(n-2)}-q^{k(n-4)}\right) z^{\prime} \\
& =0 .
\end{aligned}
$$

For $i=2$, (4) becomes

$$
\frac{[k]_{q}}{k} x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} h_{2, k} \cdot v^{\prime} \otimes w^{\prime}-\frac{[2 k]_{q}}{k} x_{1}^{-} x_{2, k}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{2, k} \cdot w^{\prime}
$$

which gives

$$
\begin{aligned}
h_{2, k} . z^{\prime} & =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-3)}-q^{k(n-5)}+q^{k(n-5)}-q^{k(-n-1)}+q^{k(n-7)}-q^{k(n-3)}\right) z^{\prime} \\
& =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-7)}-q^{k(-n-1)}\right) z^{\prime} .
\end{aligned}
$$

These values for $h_{1, k} . z^{\prime}$ and $h_{2, k} . z^{\prime}$ give the polynomials for $K_{2}$ as

$$
T_{1}(u)=1, \quad T_{2}(u)=\prod_{j=1}^{n-3}\left(1-u a q^{-n-1+2 j}\right)=\prod_{j=1}^{n-3}\left(1-u a q^{-3} q^{-n+2+2 j}\right)
$$

By Proposition 1.8, $K_{2}$ is isomorphic to the minimal affinization $V_{a q^{-3}}(0, n-3)$, and we have an exact sequence

$$
0 \rightarrow V_{a q^{-3}}(0, n-3) \rightarrow V_{a q^{-2}}(0, n-2) \otimes V_{a q^{n-3}}(1,0) \rightarrow K_{1} \rightarrow 0 .
$$

Putting this sequence together with sequence (3) proves Proposition 2.1.

Denote by $W_{a}(m, n)$ the $q$-character $\chi_{q}\left(V_{a}(m, n)\right)$ of the $U_{q}(\hat{\mathfrak{g}})$-module $V_{a}(m, n)$. The following corollary is an immediate consequence of Proposition 2.1.

Corollary 2.2 For $a \in \mathbb{C}^{*}, n \geq 0$, $W_{a}(0, n)=W_{a q^{-1}}(0, n-1) W_{a q^{n-1}}(0,1)-W_{a q^{-2}}(0, n-2) W_{a q^{n-2}}(1,0)+W_{a q^{-3}}(0, n-3)$. (Terms of the form $W_{b}(0, m)$ with $m<0$ are understood to be zero.)

This corollary enables us to compute $W_{a}(0, n)$ by induction on $n$. The proof is straightforward, if lengthy.

Proposition 2.3 For $a \in \mathbb{C}^{*}, n \geq 0$, the $q$-character $W_{a q}(0, n)$ is given by

$$
\sum_{i=1}^{n+1} \prod_{j=1}^{n+1-i} Y_{2, a q^{2 j-(n+1)}} \sum_{k=1}^{i} \prod_{r=1}^{i-k} Y_{1, a q^{n-2(r+k-2)}} Y_{2, a q^{n+1-2(r+k-2)}}^{-1} \prod_{s=1}^{k-1} Y_{1, a q^{n-2(s-2)}}^{-1}
$$

### 2.2 Computation of $W_{a q}(1, n)$

The proof of the following proposition is similar to that of Proposition 2.1.

Proposition 2.4 For $a \in \mathbb{C}^{*}, n \geq 1$, there exists an exact sequence of $U_{q}(\hat{\mathfrak{g}})$ modules

$$
0 \rightarrow V_{a q}(0, n-1) \rightarrow V_{a q^{-n-2}}(1,0) \otimes V_{a}(0, n) \rightarrow V_{a}(1, n) \rightarrow 0 .
$$

The following result is immediate from Proposition 2.4.

Corollary 2.5 For $a \in \mathbb{C}^{*}, n \geq 0$,

$$
W_{a}(1, n)=W_{a}(0, n) W_{a q^{-n-2}}(1,0)-W_{a q}(0, n-1)
$$

(Here, $W_{a q}(0, n)$ is interpreted as zero if $\left.n<0\right)$.

This leads to

Proposition 2.6 For $a \in \mathbb{C}^{*}, n \geq 0$,

$$
\begin{aligned}
W_{a q}(1, n) & =\left(Y_{1, a q^{-n-2}}+Y_{2, a q^{-n-1}} Y_{1, a q^{-n}}^{-1}\right) W_{a q}(0, n) \\
& +Y_{2, a q^{-n+1}}^{-1} \sum_{k=1}^{n+1} \prod_{r=1}^{n+1-k} Y_{1, a q^{n-2(r+k-2)}} Y_{2, a q^{n+1-2(r+k-2)}}^{-1} \prod_{s=1}^{k-1} Y_{1, a q^{n-2(s-2)}}^{-1} .
\end{aligned}
$$

### 2.3 Computation of $W_{a q}(m, n)$

Proposition 2.7 For $m, n \geq 0, a \in \mathbb{C}^{*}$, there exists an exact sequence of $U_{q}(\hat{\mathfrak{g}})$ modules

$$
\begin{aligned}
0 \rightarrow V_{a}(m-3, n) \rightarrow V_{a q^{-2 m-n+1}}(0,1) & \otimes V_{a}(m-2, n) \\
& \downarrow \\
& V_{a q^{-2 m-n}}(1,0)
\end{aligned} V_{a}(m-1, n) \rightarrow V_{a}(m, n) \rightarrow 0 .
$$

Proof. We include some of the details of this proof as it involves a new feature (a simpler version of which was actually used in the proof of Proposition 2.1). First, we find as in the proof of Proposition 2.1 that $V_{a}(m, n)$ is a quotient of the tensor product of evaluation representations

$$
V_{c}(1,0) \otimes V_{d}(m-1, n)
$$

where the polynomials for $V_{d}(m-1, n)$ are

$$
R_{1}(u)=\prod_{j=1}^{m-1}\left(1-u a q^{-2 m-n+2 j}\right), \quad R_{2}(u)=\prod_{j=1}^{n}\left(1-u a q^{-n-1+2 j}\right)
$$

and those of $V_{c}(1,0)$ are

$$
Q_{1}(u)=1-u a q^{-2 m-n}, \quad Q_{2}(u)=1
$$

Let $v \neq 0$ be an L-highest weight vector in $V_{\left.a q^{-2 m-n}\right)}(1,0)$ and $w \neq 0$ an L-highest weight vector in $V_{a}(m-1, n)$. As $U_{q}(\mathfrak{g})$-modules

$$
\begin{aligned}
V_{a}(m, n) & \cong V_{q}\left(m \lambda_{1}+n \lambda_{2}\right) \\
V_{c}(1,0) & \cong V_{q}\left(\lambda_{1}\right) \\
V_{d}(m-1, n) & \cong V_{q}\left((m-1) \lambda_{1}+n \lambda_{2}\right) .
\end{aligned}
$$

We have

$$
\begin{aligned}
& V_{q}\left(\lambda_{1}\right) \otimes V_{q}\left((m-1) \lambda_{1}+n \lambda_{2}\right) \cong \\
& \quad V_{q}\left((m-2) \lambda_{1}+(n+1) \lambda_{2}\right) \oplus V_{q}\left((m-1) \lambda_{1}+(n-1) \lambda_{2}\right) \oplus V_{q}\left(m \lambda_{1}+n \lambda_{2}\right) .
\end{aligned}
$$

So the kernel $K$ of the quotient map

$$
V_{c}(1,0) \otimes V_{d}(m-1, n) \rightarrow V_{a}(m, n)
$$

is isomorphic to $V_{q}\left((m-2) \lambda_{1}+(n+1) \lambda_{2}\right) \oplus V_{q}\left((m-1) \lambda_{1}+(n-1) \lambda_{2}\right)$ as a $U_{q}(\mathfrak{g})-$ module. Let $z$ be a non-zero vector in $K$ of weight $(m-2) \lambda_{1}+(n+1) \lambda_{2}$. As this is the maximal weight in $K, z$ is L-highest weight. Then $z$ generates $K$ as a $U_{q}(\hat{\mathfrak{g}})$-module. Indeed, let

$$
J=U_{q}(\hat{\mathfrak{g}}) . z \subseteq K
$$

As a $U_{q}(\mathfrak{g})$-module, either

$$
J \cong V_{q}\left((m-2) \lambda_{1}+(n+1) \lambda_{2}\right)
$$

or

$$
J \cong V_{q}\left((m-2) \lambda_{1}+(n+1) \lambda_{2}\right) \oplus V_{q}\left((m-1) \lambda_{1}+(n-1) \lambda_{2}\right)
$$

In the former case, $J$ would be an evaluation representation; but the calculations below will show the L-highest weight of $z$ is not that of an evaluation representation. This contradiction shows that $J=K$, i.e. that $K$ is generated by $z$. (A similar argument is also applicable to the $C_{2}$ case in the next section.)

Using the $U_{q}(\mathfrak{g})$-structure of these modules given above,

$$
z=A x_{1}^{-} \cdot v \otimes w+B v \otimes x_{1}^{-} \cdot w
$$

for some $A, B \in \mathbb{C}$. Then

$$
\begin{aligned}
h_{i, k} . z & =\Delta\left(h_{i, k}\right) . z \\
& =A\left(h_{i, k} x_{1}^{-} \cdot v \otimes w+x_{1}^{-} \cdot v \otimes h_{i, k} \cdot w+\mathrm{a} \text { term in } U_{+}^{\prime} x_{1}^{-} \cdot v \otimes U_{-}^{\prime} \cdot w\right) \\
& +B\left(h_{i, k} \cdot v \otimes x_{1}^{-} \cdot w+v \otimes h_{i, k} x_{1}^{-} \cdot w\right) .
\end{aligned}
$$

But, $U_{+}^{\prime} x_{1}^{-} . v \otimes U_{-}^{\prime} . w$ gives unknown scalar multiples of $v \otimes x_{1}^{-} . w$, so in order to calculate $h_{i, k} . z$ we calculate

$$
\begin{equation*}
h_{i, k} x_{1}^{-} . v \otimes w+x_{1}^{-} . v \otimes h_{i, k} . w . \tag{5}
\end{equation*}
$$

Now,

$$
\begin{aligned}
& \frac{Q_{1}\left(q^{-2} u\right)}{Q_{1}(u)}=\frac{1-u a q^{-2 m-n-2}}{1-u a q^{-n-2 m}}, \quad \frac{Q_{2}\left(q^{-2} u\right)}{Q_{2}(u)}=1, \\
& \frac{R_{1}\left(q^{-2} u\right)}{R_{1}(u)}=\frac{1-u a q^{-2 m-n}}{1-u a q^{-n-2}}, \quad \frac{R_{2}\left(q^{-2} u\right)}{R_{2}(u)}=\frac{1-u a q^{-n-1}}{1-u a q^{n-1}}
\end{aligned}
$$

which gives

$$
\begin{aligned}
h_{1, k} \cdot w & =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-n-2)}-q^{k(-2 m-n)}\right) w, \\
h_{1, k} \cdot v & =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-2 m-n)}-q^{k(-2 m-n-2)}\right) v, \\
h_{2, k} \cdot w & =\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-1)}-q^{k(-n-1)}\right) w, \quad h_{2, k} \cdot v=0, \\
x_{1, k}^{-} \cdot v & =a^{k} q^{k(-n-2 m)} x_{1}^{-} \cdot v .
\end{aligned}
$$

For $i=1$, (5) becomes

$$
-\frac{[2 k]_{q}}{k} x_{1, k}^{-} \cdot v \otimes w+x_{1}^{-} h_{1, k} \cdot v \otimes w+x_{1}^{-} \cdot v \otimes h_{1, k} \cdot w
$$

which gives

$$
h_{1, k} . z=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-n-2)}-q^{k(-2 m-n+2)}\right) z
$$

For $i=2$, (5) becomes

$$
\frac{[k]_{q}}{k} x_{1, k}^{-} \cdot v \otimes w+x_{1}^{-} h_{2, k} \cdot v \otimes w+x_{1}^{-} \cdot v \otimes h_{2, k} \cdot w
$$

which gives

$$
h_{2, k} . z=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-2 m-n+1)}-q^{k(-2 m-n-1)}+q^{k(n-1)}-q^{k(-n-1)}\right) z .
$$

These values for $h_{1, k} . z$ and $h_{2, k} . z$ give the polynomials for $K$ as

$$
\begin{aligned}
& S_{1}(u)=\prod_{j=2}^{m-1}\left(1-u a q^{-2 m-n+2 j}\right)=\prod_{j=1}^{m-2}\left(1-u a q^{-2 m-n+2+2 j}\right) \\
& S_{2}(u)=\left(1-u a^{-2 m-n+1}\right) \prod_{j=1}^{n}\left(1-u a q^{-n-1+2 j}\right)
\end{aligned}
$$

This implies that $K$ is not an evaluation representation, as the roots of $S_{2}$ do not form a $q$-segment.

Now the evaluation representation $V_{a}(m-2, n)$ has polynomials

$$
T_{1}(u)=\prod_{j=1}^{m-2}\left(1-u a q^{-2 m-n+2 j}\right), \quad T_{2}(u)=\prod_{j=1}^{n}\left(1-u a q^{-n-1+2 j}\right),
$$

so $K$ is a quotient of the tensor product

$$
V_{a q^{-2 m-n+1}}(0,1) \otimes V_{a}(m-2, n)
$$

where $V_{a q^{-2 m-n+1}}(0,1)$ has polynomials

$$
Q_{1}(u)=1, \quad Q_{2}(u)=1-u a q^{-2 m-n+1}
$$

Let $K_{1}$ be the kernel of this quotient map. Let $v^{\prime} \neq 0$ be an L-highest weight vector in $V_{a q^{-2 m-n+1)}}(0,1)$ and $w^{\prime} \neq 0$ an L-highest weight vector in $V_{a}(m-2, n)$. Using the $U_{q}(\mathfrak{g})$-structure of these modules and the fact that $x_{1}^{-} \cdot v^{\prime}=0$, a highest weight vector in $K_{1}$ must have the form
$z^{\prime}=A^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+B^{\prime} v \otimes x_{1}^{-} x_{2}^{-} \cdot w^{\prime}+C^{\prime} x_{2}^{-} \cdot v \otimes x_{1}^{-} \cdot w^{\prime}+D^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes x_{1}^{-} x_{2}^{-} \cdot w^{\prime}$
for some $A^{\prime}, B^{\prime}, C^{\prime}, D^{\prime} \in \mathbb{C}$. So, in order to calculate $h_{i, k} . z$, we calculate

$$
\begin{equation*}
h_{i, k} x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{i, k} \cdot w^{\prime} \tag{6}
\end{equation*}
$$

Now, if $\left(U_{1}, U_{2}\right)$ are the polynomials for $V_{a q^{-2 m-n+1}}(0,1)$, we have

$$
\begin{aligned}
& \frac{U_{1}\left(q^{-2} u\right)}{U_{1}(u)}=1, \quad \frac{U_{2}\left(q^{-2} u\right)}{U_{2}(u)}=\frac{1-u a q^{-2 m-n-1}}{1-u a q^{-2 m-n+1}} \\
& \frac{T_{1}\left(q^{-2} u\right)}{T_{1}(u)}=\frac{1-u a q^{-2 m-n+2}}{1-u a q^{-n-2}}, \quad \frac{T_{2}\left(q^{-2} u\right)}{T_{2}(u)}=\frac{1-u a q^{-n-1}}{1-u a q^{n-1}}
\end{aligned}
$$

which gives

$$
\begin{aligned}
& h_{1, k} \cdot v^{\prime}=0, \quad h_{1, k} \cdot w^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-n-2)}-q^{k(-2 m-n+2)}\right) w^{\prime} \\
& h_{2, k} \cdot w^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-1)}-q^{k(-n-1)}\right) w^{\prime} \\
& h_{2, k} \cdot v^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-2 m-n+1)}-q^{k(-2 m-n-1)}\right) v^{\prime} \\
& x_{2, k}^{-} \cdot v^{\prime}=a^{k} q^{k(-n-2 m+1)} x_{2}^{-} \cdot v^{\prime}
\end{aligned}
$$

To calculate (6) it is also necessary to find an expression for $x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}$. For some scalars $E_{k}^{\prime}(k>0)$, we have

$$
x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}=E_{k}^{\prime} x_{1}^{-} x_{2}^{-} \cdot v^{\prime}
$$

Applying $x_{1}^{+}$gives

$$
\frac{\Phi_{1, k}^{+}}{q-q^{-1}} x_{2}^{-} \cdot v^{\prime}=E_{k}^{\prime} x_{2}^{-} \cdot v^{\prime}
$$

By Theorem 1.3,

$$
\begin{aligned}
\sum_{k=0}^{\infty} u^{k} \Phi_{1, k}^{+} x_{2}^{-} \cdot v^{\prime} & =k_{1} \exp \left(\left(q-q^{-1}\right) \sum_{s=1}^{\infty} h_{1, s} u^{s}\right) x_{2}^{-} \cdot v^{\prime} \\
& =q \exp \left(\left(q-q^{-1}\right) \sum_{s=1}^{\infty} u^{s} \frac{[s]_{q}}{s}\right) x_{2}^{-} \cdot v^{\prime} \\
& =q \frac{\left(1-a u q^{-2 m-n}\right)}{\left(1-a u q^{-2 m-n+2}\right)} x_{2}^{-} \cdot v^{\prime}
\end{aligned}
$$

so

$$
\Phi_{1, k}^{+} x_{2}^{-} \cdot v^{\prime}=a^{k} q^{k(-2 m-n+2)} x_{2}^{-} \cdot v^{\prime}
$$

This gives

$$
E_{k}^{\prime}=a^{k} q^{k(-2 m-n+2)}
$$

and hence

$$
x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime}=a^{k} q^{k(-2 m-n+2)} x_{1}^{-} x_{2}^{-} \cdot v^{\prime}
$$

For $i=1$, (6) now becomes
$-\frac{[2 k]_{q}}{k} x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} h_{1, k} \cdot v^{\prime} \otimes w^{\prime}+\frac{[k]_{q}}{k} x_{1}^{-} x_{2, k}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{1, k} \cdot w^{\prime}$,
which gives

$$
h_{1, k} . z^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(-n-2)}-q^{k(-2 m-n+4)}\right) z^{\prime} .
$$

For $i=2$, (6) becomes
$\frac{[k]_{q}}{k} x_{1, k}^{-} x_{2}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} h_{2, k} \cdot v^{\prime} \otimes w^{\prime}-\frac{[2 k]_{q}}{k} x_{1}^{-} x_{2, k}^{-} \cdot v^{\prime} \otimes w^{\prime}+x_{1}^{-} x_{2}^{-} \cdot v^{\prime} \otimes h_{2, k} \cdot w^{\prime}$,
which gives

$$
h_{2, k} \cdot z^{\prime}=\frac{a^{k}}{k\left(q-q^{-1}\right)}\left(q^{k(n-1)}-q^{k(-n-1)}\right) z^{\prime} .
$$

These values for $h_{1, k} . z^{\prime}$ and $h_{2, k} . z^{\prime}$ give the polynomials for $K_{1}$ as

$$
\begin{aligned}
& V_{1}(u)=\prod_{j=2}^{m-2}\left(1-u a q^{-2 m-n+2+2 j}\right)=\prod_{j=1}^{m-3}\left(1-u a q^{-2 m-n+4+2 j}\right) \\
& V_{2}(u)=\prod_{j=1}^{n}\left(1-u a q^{-n-1+2 j}\right) .
\end{aligned}
$$

The roots of $V_{1}\left(\right.$ resp. $\left.V_{2}\right)$ form a $q$-segment with centre $a^{-1} q^{n+m-2}$ (resp. $a^{-1}$ ), and since

$$
\frac{a^{-1}}{a^{-1} q^{n+m-2}}=q^{-n-m+2},
$$

$K_{1}$ is an evaluation representation by Proposition 1.8.
We now have two exact sequences

$$
\begin{aligned}
& 0 \rightarrow K \rightarrow V_{a q^{-2 m-n}}(1,0) \otimes V_{a}(m-1, n) \rightarrow V_{a}(m, n) \rightarrow 0 \\
& 0 \rightarrow V_{a}(m-3, n) \rightarrow V_{a q^{-2 m-n+1}}(0,1) \otimes V_{a}(m-2, n) \rightarrow K \rightarrow 0
\end{aligned}
$$

and putting these together completes the proof of Proposition 2.7.

Corollary 2.8 Let $a \in \mathbb{C}^{*}, m, n \geq 0$. Then
$W_{a}(m, n)=W_{a}(m-1, n) W_{a q^{-2 m-n}}(1,0)-W_{a}(m-2, n) W_{a q^{-2 m-n+1}}(0,1)+W_{a}(m-3, n)$.

This leads to
Theorem 2.9 Let $a \in \mathbb{C}^{*}, m, n \geq 0$. Then, $W_{a q}(m, n)=A_{a, n} \sum_{i=1}^{m} \prod_{j=1}^{m-i} Y_{1, a q^{2 j-n-2(m+1)}}$ $\sum_{k=1}^{i} \prod_{r=1}^{i-k} Y_{2, a q^{-n-3-2(r+k-2)}} Y_{1, a q-n-2-2(r+k-2)}^{-1} \prod_{s=1}^{k-1} Y_{2, a q-n-1-2(s-1)}^{-1}$ $+W_{a q}(0, n) \sum_{i=1}^{m+1} \prod_{j=1}^{m+1-i} Y_{1, a q^{2 j-n-2(m+1)}} \prod_{r=1}^{i-1} Y_{2, a q^{-n-1-2(r-1)}} Y_{1, a q^{-n-2(r-1)}}^{-1}$, where

$$
A_{a, n}=Y_{2, a q^{-n+1}}^{-1} \sum_{k=1}^{n+1} \prod_{r=1}^{n+1-k} Y_{1, a q^{n-2(r+k-2)}} Y_{2, a q^{n+1-2(r+k-2)}}^{-1} \prod_{s=1}^{k-1} Y_{1, a q^{n-2(s-2)}}^{-1}
$$

## 3. The $\mathrm{C}_{2}$ case

In this section, $\mathfrak{g}$ denotes a complex simple Lie algebra of type $C_{2}$. We take

$$
A=\left(\begin{array}{cc}
2 & -1 \\
-2 & 2
\end{array}\right), \quad d_{1}=2, d_{2}=1
$$

If $m>0, n \geq 0$, we denote by $V_{a}(m, n)$ the irreducible representation of $U_{q}(\hat{\mathfrak{g}})$ having polynomials $\left(P_{1}, P_{2}\right)$ with $\operatorname{deg} P_{1}=m>0$ and $\operatorname{deg} P_{2}=n$ and in which the inverse roots of $P_{1}$ form a $q$-segment with centre $a$. If $m=0, n>0$ the parameter $a$ will denote the centre of the $q^{2}$-segment formed by the inverse roots of $P_{2}$. As the proofs are similar to those in the $\mathrm{A}_{2}$ case, we omit many of the details.

### 3.1 Some exact sequences

The proof of the following proposition is similar to that of Proposition 2.1.

Proposition 3.1 Let $a \in \mathbb{C}^{*}, r \geq 1$. There exist exact sequences of $U_{q}(\hat{\mathfrak{g}})$-modules

$$
\begin{gathered}
0 \rightarrow V_{a q^{4}}(r-1,2) \rightarrow V_{a q^{-2 r}}(1,0) \otimes V_{a q^{2}}(r, 0) \rightarrow V_{a}(r+1,0) \rightarrow 0 \\
0 \rightarrow V_{a q^{2}}(r-2,0) \rightarrow V_{a}(r-1,0) \otimes V_{a q^{-2 r-2}}(1,0) \\
\downarrow \\
\\
V_{a q^{-2 r-4}}(0,1) \otimes V_{a}(r-1,1) \rightarrow V_{a}(r-1,2) \rightarrow 0 \\
0 \rightarrow V_{a q^{2}}(r-2,1) \rightarrow \\
V_{a q^{-2 r-2}}(0,1) \otimes V_{a}(r-1,0) \rightarrow V_{a}(r-1,1) \rightarrow 0 .
\end{gathered}
$$

Corollary 3.2 Let $a \in \mathbb{C}^{*}, r \geq 0$. Then,
$W_{a}(r+1,0)=W_{a q^{2}}(r, 0) W_{a q^{-2 r}}(1,0)-W_{a q^{4}}(r-1,2)$,
$W_{a}(r-1,2)=W_{a}(r-1,1) W_{a q^{-2 r-4}}(0,1)-W_{a}(r-1,0) W_{a q^{-2 r-2}}(1,0)+W_{a q^{2}}(r-2,0)$,
$W_{a}(r-1,1)=W_{a}(r-1,0) W_{a q^{-2 r-2}}(0,1)-W_{a q^{2}}(r-2,1)$.
(Terms involving $W_{a}(r, s)$ with $r<0$ are understood to be zero.)

Corollary 3.2 gives an inductive scheme for calculating $W_{a}(r+1,0), W_{a}(r-1,2)$ and $W_{a}(r+1,1)$, starting with the formula for $W_{a}(1,0)$ which is given in Section 1.7. In the next section, we shall obtain a similar scheme for calculating $W_{a}(r, s)$ for arbitrary $r, s \geq 0$.

### 3.2 Computation of $W_{a}(r, s)$

Proposition 3.3 For $a \in \mathbb{C}^{*}, r, s \geq 0$, there is an exact sequence of $U_{q}(\hat{\mathfrak{g}})$-modules

$$
0 \rightarrow V_{a}(r, s-5) \rightarrow V_{a}(r, s-4) \otimes V_{a q^{-2 r-2 s}}(0,1)
$$

$\downarrow$

$$
V_{a q^{-2 r-2 s}}(1,0) \otimes V_{a}(r, s-3)
$$

$\downarrow$

$$
V_{a q^{-2 r-2 s-2}}(1,0) \otimes V_{a}(r, s-1)
$$

$\downarrow$

$$
V_{a q^{-2 r-2 s-4}}(0,1) \otimes V_{a}(r, s) \rightarrow V_{a}(r, s+1) \rightarrow 0 .
$$

(Terms of the form $V_{b}(r, s)$ with $r$ or $s<0$ are understood to be zero.)

Proof. As above, we find that the minimal affinization $V_{a}(r, s+1)$ is a quotient of the tensor product of evaluation representations

$$
V_{a q^{-2 r-2 s-4}}(0,1) \otimes V_{a}(r, s) .
$$

Let $v \neq 0$ be an L-highest weight vector in $V_{a q^{-2 r-2 s-4}}(0,1)$ and $w \neq 0$ an Lhighest weight vector in $V_{a}(r, s)$. Using the $U_{q}(\mathfrak{g})$-structure of these modules, a highest weight vector in the kernel $K$ of the quotient map

$$
V_{a q^{-2 r-2 s-4}}(0,1) \otimes V_{a}(r, s) \rightarrow V_{a}(r, s+1)
$$

has the form

$$
z=A x_{2}^{-} \cdot v \otimes w+B v \otimes x_{2}^{-} \cdot w
$$

for some $A, B \in \mathbb{C}$. Arguing as in the proof of Proposition 2.7, we find that the polynomials associated to $z$ are
$S_{1}(u)=\left(1-u a q^{-2 r-2 s-2}\right) \prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad S_{2}(u)=\prod_{j=1}^{s-1}\left(1-u a q^{-2 r-2-2 j}\right)$.
This implies that $K$ is not a minimal affinization as the roots of $S_{1}$ do not form a $q^{2}$-segment. But $K$ appears in the quotient of the tensor product of

$$
V_{a q^{-2 r-2 s-2}}(1,0) \otimes V_{a}(r, s-1) .
$$

where $V_{a q^{-2 r-2}}(1,0)$ has polynomials

$$
T_{1}(u)=1-u a q^{-2 r-2-2 s}, \quad T_{2}(u)=1
$$

and $V_{a}(r, s-1)$ has polynomials

$$
U_{1}(u)=\prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad U_{2}(u)=\prod_{j=1}^{s-1}\left(1-u a q^{-2 r-2-2 j}\right)
$$

Let $K_{1}$ be the kernel of the quotient map

$$
V_{a q^{-2 r-2 s-2}}(1,0) \otimes V_{a}(r, s-1) \rightarrow K
$$

Arguing as above, we find that a $U_{q}(\hat{\mathfrak{g}})$-highest weight vector in $K_{1}$ must have polynomials

$$
S_{1}^{\prime}(u)=\left(1-u a q^{-2 r-2 s}\right) \prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad S_{2}^{\prime}(u)=\prod_{j=1}^{s-3}\left(1-u a q^{-2 r-2-2 j}\right)
$$

This implies that $K_{1}$ is not a minimal affinization as the roots of $S_{1}(u)$ do not form a $q^{2}$-segment. But $K_{1}$ appears as a quotient of the tensor product

$$
V_{a q^{-2 r-2 s}}(1,0) \otimes V_{a}(r, s-3)
$$

where $V_{a q^{-2 r-2 s}}(1,0)$ has polynomials

$$
T_{1}^{\prime}(u)=1-u a q^{-2 r-2}, \quad T_{2}^{\prime}(u)=1,
$$

and $V_{a}(r, s-1)$ has polynomials

$$
U_{1}^{\prime}(u)=\prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad U_{2}^{\prime}(u)=\prod_{j=1}^{s-3}\left(1-u a q^{-2 r-2-2 j}\right)
$$

Let $K_{2}$ be the kernel of the quotient map

$$
V_{a q^{-2 r-2 s}}(1,0) \otimes V_{a}(r, s-3) \rightarrow K_{1}
$$

We find that a $U_{q}(\hat{\mathfrak{g}})$-highest weight vector in $K_{2}$ must have polynomials

$$
T_{1}^{\prime \prime}(u)=\prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad T_{2}^{\prime \prime}(u)=\left(1-u a q^{-2 r-2 s}\right) \prod_{j=1}^{s-4}\left(1-u a q^{-2 r-2-2 j}\right)
$$

This implies that $K_{2}$ is not a minimal affinization as the roots of $S_{1}(u)$ do not form a $q^{2}$-segment. But $K_{2}$ appears as a quotient of the tensor product

$$
V_{a q^{-2 r-2 s}}(0,1) \otimes V_{a}(r, s-4),
$$

where $V_{a q^{-2 r-2 s}}(0,1)$ has polynomials

$$
W_{1}(u)=1, \quad W_{2}(u)=1-u a q^{-2 r-2 s}
$$

and $V_{a}(r, s-4)$ has polynomials

$$
W_{1}^{\prime}(u)=\prod_{j=1}^{r}\left(1-u a q^{2 r-4 j+2}\right), \quad W_{2}^{\prime}(u)=\prod_{j=1}^{s-4}\left(1-u a q^{-2 r-2 j-2}\right)
$$

Let $K_{3}$ be the kernel of this quotient map. Dualizing the inclusion map

$$
K_{3} \rightarrow V_{a q^{-2 r-2 s}}(0,1) \otimes V_{a}(r, s-4)
$$

gives a non-zero homomorphism of $U_{q}(\hat{\mathfrak{g}})$-modules

$$
V_{a}(r, s-4) \rightarrow K_{3} \otimes V_{a q^{-2 r-2 s}}^{t}(0,1)
$$

By Lemma 1.6,

$$
V_{a q^{-2 r-2}}^{t}(0,1) \cong V_{a q^{-2 r-2 s+6}}(0,1)
$$

so we have a non-zero $U_{q}(\hat{\mathfrak{g}})$-module homomorphism

$$
V_{a}(r, s-4) \rightarrow K_{3} \otimes V_{a q^{-2 r-2 s+6}}(0,1) .
$$

If $K_{3}$ has polynomials $\left(U_{1}^{\prime \prime}, U_{2}^{\prime \prime}\right)$,

$$
\left(1-u a q^{-2 r-2 s+6}\right) U_{2}^{\prime \prime}(u)=\prod_{j=1}^{s-4}\left(1-u a q^{-2 r-2-2 j}\right)
$$

So $K_{3}$ has polynomials

$$
U_{1}^{\prime \prime}(u)=\prod_{j=1}^{r}\left(1-u a q^{2 r+2-4 j}\right), \quad U_{2}^{\prime \prime}(u)=\prod_{j=1}^{s-5}\left(1-u a q^{-2 r-2-2 j}\right)
$$

Hence, the inverse roots of $U_{1}^{\prime \prime}$ form a $q^{2}$-segment with centre $a$, and those of $U_{2}^{\prime \prime}$ form a $q$-segment with centre $a q^{-2 r-s+2}$. By Proposition 1.8,

$$
K_{3} \cong V_{a}(r, s-5)
$$

Summarizing, we have the following exact sequences of $U_{q}(\hat{\mathfrak{g}})$-modules:

$$
\begin{aligned}
& 0 \rightarrow K \rightarrow V_{a q^{-2 r-2 s-4}}(0,1) \otimes V_{a}(r, s) \rightarrow V_{a}(r, s+1) \rightarrow 0 \\
& 0 \rightarrow K_{1} \rightarrow V_{a q^{-2 r-2}}(1,0) \otimes V_{a}(r, s-1) \rightarrow K \rightarrow 0 \\
& 0 \rightarrow K_{2} \rightarrow V_{a q^{-2 r-2 s}}(1,0) \otimes V_{a}(r, s-3) \rightarrow K_{1} \rightarrow 0 \\
& 0 \rightarrow V_{a}(r, s-5) \rightarrow V_{a}(r, s-4) \otimes V_{a q^{-2 r-2 s}}(0,1) \rightarrow K_{2} \rightarrow 0,
\end{aligned}
$$

and the proposition follows.

Corollary 3.4 For $a \in \mathbb{C}^{*}, r, s \geq 0$, we have

$$
\begin{aligned}
W_{a}(r, s+1)=W_{a q^{-2 r-2 s-4}} & (0,1) W_{a}(r, s)+W_{a q^{-2 r-2 s}}(1,0) W_{a}(r, s-3) \\
& -W_{a q^{-2 r-2 s-2}}(1,0) W_{a}(r, s-1)-W_{a}(r, s-5) .
\end{aligned}
$$

## 4. The $\mathrm{G}_{2}$ Case

In this section $\mathfrak{g}$ denotes a complex simple Lie algebra of type $G_{2}$. We take

$$
A=\left(\begin{array}{cc}
2 & -1 \\
-3 & 2
\end{array}\right), \quad d_{1}=3, d_{2}=1
$$

We have

$$
\alpha_{1}=2 \lambda_{1}-3 \lambda_{2}, \quad \alpha_{2}=-\lambda_{1}+2 \lambda_{2} \quad \theta=2 \alpha_{1}+3 \alpha_{2}=\lambda_{1} .
$$

### 4.1 A special notation

We shall attempt to understand the $U_{q}(\mathfrak{g})$-structure of certain minimal affinizations of $U_{q}(\hat{\mathfrak{g}})$. Since the necessary calculations are rather complex, we have simplified their presentation by employing the following 'approximation' notation: if $v_{1}, \ldots, v_{M}, v_{1}^{\prime}, \ldots, v_{N}^{\prime}$ are vectors in a vector space $V$, we write

$$
v_{1}+\cdots+v_{M} \approx v_{1}^{\prime}+\cdots+v_{N}^{\prime}
$$

to mean that there exist $t_{1}, \ldots, t_{M}, t_{1}^{\prime}, \ldots, t_{N}^{\prime} \in C^{*}$ such that

$$
\sum_{r=1}^{M} t_{r} v_{r}=\sum_{s=1}^{N} t_{s}^{\prime} v_{s}^{\prime}
$$

For example, we shall make extensive use of the defining relations

$$
\begin{gather*}
x_{i, r+1}^{ \pm} x_{j, s}^{ \pm}-q^{ \pm a_{i j}} x_{j, s}^{ \pm} x_{i, r+1}^{ \pm}=q^{ \pm a_{i j}} x_{i, r}^{ \pm} x_{j, s+1}^{ \pm}-x_{j, s+1}^{ \pm} x_{i, r}^{ \pm}  \tag{7}\\
\sum_{\pi \in \sum_{m}} \sum_{k=0}^{m}(-1)^{k}\left[{ }_{k}^{m}\right]_{q_{i}} x_{i, r_{\pi(1)}}^{ \pm} \ldots x_{i, r_{\pi(k)}}^{ \pm} x_{j, s}^{ \pm} x_{i, r_{\pi(k+1)}}^{ \pm} \ldots x_{i, r_{\pi(m)}}^{ \pm}=0 \text { if } i \neq j
\end{gather*}
$$

Using the approximation notation, (7) becomes

$$
\begin{equation*}
x_{i, r+1}^{ \pm} x_{j, s}^{ \pm}-x_{j, s}^{ \pm} x_{i, r+1}^{ \pm} \approx x_{i, r}^{ \pm} x_{j, s+1}^{ \pm}-x_{j, s+1}^{ \pm} x_{i, r}^{ \pm} . \tag{9}
\end{equation*}
$$

In particular,

$$
\begin{equation*}
x_{i, \pm 1}^{ \pm} x_{i} \approx x_{i} x_{i, \pm 1}^{ \pm} \tag{10}
\end{equation*}
$$

Similarly, we have the following special cases of (8):

$$
\begin{gather*}
\left(x_{1}^{+}\right)^{2} x_{2}^{+}+x_{1}^{+} x_{2}^{+} x_{1}^{+}+x_{2}^{+}\left(x_{1}^{+}\right)^{2} \approx 0  \tag{11}\\
\left(x_{2}^{+}\right)^{4} x_{1}^{+}+\left(x_{2}^{+}\right)^{3} x_{1}^{+} x_{2}^{+}+\left(x_{2}^{+}\right)^{2} x_{1}^{+}\left(x_{2}^{+}\right)^{2}+x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3}+x_{1}^{+}\left(x_{2}^{+}\right)^{4} \approx 0 \tag{12}
\end{gather*}
$$

### 4.2 Multiplicities

Let $\lambda=r \lambda_{1}+\lambda_{2} \in P^{+}$, with $r \geq 0$, and let $V(\mathbf{P})$ be a minimal affinization of $\lambda$. Choose $\mathbf{Q}$ and $\mathbf{R}$ such that $V(\mathbf{Q})$ is a minimal affinization of $r \lambda_{1}, V(\mathbf{R})$ is a minimal affinization of $\lambda_{2}$ and $V(\mathbf{P})$ is isomorphic to a quotient of $V(\mathbf{Q}) \otimes V(\mathbf{R})$.

Lemma 4.1 As $U_{q}(\mathfrak{g})$-modules, we have $V_{q}\left(r \lambda_{1}\right) \otimes V_{q}\left(\lambda_{2}\right) \cong V_{q}\left(r \lambda_{1}+\lambda_{2}\right) \oplus V_{q}\left(r \lambda_{1}+\lambda_{2}-\theta\right) \oplus V_{q}\left(r \lambda_{1}+\lambda_{2}-\left(\alpha_{1}+\alpha_{2}\right)\right)$.

Proof. In view of the results of Section 1.4, it suffices to prove the analogous classical result, which we leave to the reader.

Proposition 4.2 As $U_{q}(\mathfrak{g})$-modules, we have

$$
V(\mathbf{Q}) \otimes V(\mathbf{R}) \cong V_{q}(\lambda) \oplus \bigoplus_{j=1}^{r}\left[2 V_{q}(\lambda-j \theta) \oplus V_{q}\left(\lambda-\left(\alpha_{1}+\alpha_{2}\right)-(j-1) \theta\right)\right]
$$

Proof. By Proposition 1.11, as $U_{q}(\mathfrak{g})$-modules,

$$
V(\mathbf{Q}) \cong \bigoplus_{j=0}^{r} V_{q}\left((r-j) \lambda_{1}\right), \quad V(\mathbf{R}) \cong V_{q}\left(\lambda_{2}\right)
$$

The result now follows from Lemma 4.1.

For any $U_{q}(\mathfrak{g})$-module $V$, set

$$
V_{\lambda}^{+}=\left\{v \in V_{\lambda} \mid x_{i}^{+} . v=0 \text { for all } i \in I\right\}, \quad m_{\lambda}(V)=\operatorname{dim} V_{\lambda}^{+},
$$

so that $m_{\lambda}(V)$ is the multiplicity of $V_{q}(\lambda)$ in $V$.

Proposition 4.3 Let $\mu \in P^{+}$. Then,
(i) $m_{\mu}(V(\mathbf{P})) \leq 1$ if $\mu$ is of the form $\lambda-n \theta-\left(\alpha_{1}+\alpha_{2}\right)$ for some $n \in \mathbb{N}$;
(ii) $m_{\mu}(V(\mathbf{P})) \leq 2$ if $\mu$ is of the form $\lambda-n \theta$ for some $n \in \mathbb{N}$;
(iii) $m_{\mu}(V(\mathbf{P}))=0$ if $\mu$ is not of the form $\lambda-n \theta-\left(\alpha_{1}+\alpha_{2}\right)$ or $\lambda-n \theta$ for any $n \in \mathbb{N}$;
(iv) $m_{\lambda-n \theta}(V(\mathbf{P})) \geq 1$ for $0 \leq n \leq r$.

Proof. Parts (i), (ii) and (iii) follow from Proposition 4.2 and the fact that $V(\mathbf{P})$ is isomorphic to a quotient of $V(\mathbf{Q}) \otimes V(\mathbf{R})$.

To show part (iv), let the roots of the polynomial $P_{1}$ be $p_{1}, \ldots, p_{r}$. Each fundamental representation $V\left(1-u p_{j}, 1\right)$ can be identified with $V_{q}\left(\lambda_{1}\right)$ as a $U_{q}(\mathfrak{g})$-module; let $v_{\lambda_{1}} \in V_{q}\left(\lambda_{1}\right)$ be a non-zero $U_{q}(\mathfrak{g})$-highest weight vector. Then, for $1 \leq j \leq r$, there exists a non-zero vector $w_{j} \in V\left(1-u p_{j}, 1\right)_{0}^{+}$such that $x_{0}^{-} \cdot w_{j}=v_{\lambda_{1}}$. This follows since $V\left(1-u p_{j}, 1\right) \cong V\left(\lambda_{1}\right) \oplus \mathbb{C}$ as a $U_{q}(\mathfrak{g})$-module. For $1 \leq j \leq r$, consider

$$
w=w_{1} \otimes w_{2} \ldots \otimes w_{j} \otimes v_{\lambda_{1}}^{\otimes r-j} \otimes v_{\lambda_{2}}
$$

so that

$$
w \in V\left(1-u p_{1}, 1\right) \otimes \ldots \otimes V\left(1-u p_{r}, 1\right) \otimes V\left(0, P_{2}\right)
$$

Clearly, $x_{1}^{+} \cdot w=x_{2}^{+} \cdot w=0$. A lengthy but straightforward computation gives

$$
\left(x_{0}^{-}\right)^{j} \cdot w=q^{3 j(j-1) / 2}[j]_{q^{3}} v_{\lambda_{1}}^{\otimes^{r}} \otimes v_{\lambda_{2}},
$$

which is non-zero. Since $V(\mathbf{P})$ is isomorphic to a quotient of $V(\mathbf{Q}) \otimes V(\mathbf{R})$ and $V(\mathbf{Q})$ to a quotient of $V\left(1-u p_{1}, 1\right) \otimes \ldots \otimes V\left(1-u p_{r}, 1\right)$, there exists a surjective
homomorphism of $U_{q}(\hat{\mathfrak{g}})$-modules

$$
\pi: V\left(1-u p_{1}, 1\right) \otimes \ldots \otimes V\left(1-u p_{r}, 1\right) \otimes V\left(0, P_{2}\right) \rightarrow V(\mathbf{P})
$$

such that

$$
\pi\left(v_{\lambda_{1}}^{\otimes r} \otimes v_{\lambda_{2}}\right)=v_{\mathbf{P}}
$$

where $v_{\mathbf{P}} \neq 0$ is an L-highest weight vector in $V(\mathbf{P})$. Hence,

$$
\pi\left(\left(x_{0}^{-}\right)^{j} \cdot w\right) \neq 0
$$

and so $\pi(w)$ is a non-zero element of $V(\mathbf{P})_{\lambda-j \theta}^{+}$.
To prove the next proposition the following two lemmas are needed. Recall that $V(\mathbf{P})$ is an affinization of $\lambda \in P^{+}$.

Lemma 4.4 Suppose there exists a non-zero vector $v \in V(\mathbf{P})_{\mu}^{+}$such that

$$
x_{i, 1}^{+} \cdot v=x_{i,-1}^{+} \cdot v=0 \quad(i=1,2)
$$

Assume that $m_{\mu+\alpha_{i}}(V(\mathbf{P}))=0 \quad(i=1,2)$. Then, $\lambda=\mu$.

For a proof of this lemma see [2, Lemma 7.2].

Lemma 4.5 Let $\mu \in P^{+}$be such that $m_{\mu+\nu}(V(\mathbf{P}))=0$ if $\nu$ is not of the form s $\theta$ for any $s \in \mathbb{N}$. Then, $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}$maps $V(\mathbf{P})_{\mu}^{+}$to $V(\mathbf{P})_{\mu+\theta}^{+}$and, if $v \in V(\mathbf{P})_{\mu}^{+}$ is such that $x_{1, \pm 1}^{+} \cdot v \neq 0$, then $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v \neq 0$.

Proof. It is obvious for weight reasons that $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}$maps $V(\mathbf{P})_{\mu}^{+}$to $V(\mathbf{P})_{\mu+\theta}$. Let $v \in V(\mathbf{P})_{\mu}^{+}$be such that

$$
x_{i}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0 \quad(i=1,2) .
$$

For $i=1$ we consider

$$
\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}
$$

By (11), we have

$$
\left(x_{1}^{+}\right)^{2} x_{2}^{+} \approx x_{1}^{+} x_{2}^{+} x_{1}^{+}+x_{2}^{+}\left(x_{1}^{+}\right)^{2},
$$

so

$$
\begin{aligned}
\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} & \approx x_{1}^{+} x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+}+x_{2}^{+}\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} \\
& \approx x_{1}^{+} x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+}+\left(x_{2}^{+} x_{1}^{+}\right)^{2} x_{2}^{+} x_{1, \pm 1}^{+}+\left(x_{2}^{+}\right)^{2}\left(x_{1}^{+}\right)^{2} x_{2}^{+} x_{1, \pm 1}^{+}
\end{aligned}
$$

by (11) again. But, by (9),

$$
x_{2}^{+} x_{1, \pm 1}^{+} \approx\left(x_{1, \pm 1}^{+} x_{2}^{+}+x_{2, \mp 1}^{+} x_{1}^{+}+x_{1}^{+} x_{2, \mp 1}^{+}\right),
$$

so we have
$\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \approx\left(\left(x_{1}^{+} x_{2}^{+}\right)^{2}+\left(x_{2}^{+} x_{1}^{+}\right)^{2}+\left(x_{2}^{+}\right)^{2}\left(x_{1}^{+}\right)^{2}\right)\left(x_{1, \pm 1}^{+} x_{2}^{+}+x_{2, \mp 1}^{+} x_{1}^{+}+x_{1}^{+} x_{2, \mp 1}^{+}\right)$.
Now, by (11),

$$
x_{1}^{+} x_{2}^{+} x_{1}^{+} x_{2}^{+} x_{1}^{+} x_{2, \mp 1}^{+} \approx x_{1}^{+} x_{2}^{+}\left(x_{1}^{+}\right)^{2} x_{2}^{+} x_{2, \mp 1}^{+}+x_{1}^{+}\left(x_{2}^{+}\right)^{2}\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+},
$$

so

$$
\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+}+U_{q}(\hat{\mathfrak{g}})\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+}+U_{q}(\hat{\mathfrak{g}}) \cdot x_{2}^{+} x_{2, \mp 1}^{+}
$$

But, by (11) again,

$$
\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{1}^{+}, \quad x_{2}^{+} x_{2, \mp 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+},
$$

so

$$
\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+} .
$$

Hence, for $v \in V(\mathbf{P})_{\mu}^{+}$we have

$$
\left(x_{1}^{+}\right)^{2}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0 .
$$

For $i=2$ we consider $x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}$. As above, we have
$x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \approx\left(x_{2}^{+}\right)^{4} x_{1}^{+} x_{1, \pm 1}^{+}+\left(x_{2}^{+}\right)^{3} x_{1}^{+} x_{2}^{+} x_{1, \pm 1}^{+}+x_{1}^{+}\left(x_{2}^{+}\right)^{4} x_{1, \pm 1}^{+}+\left(x_{2}^{+}\right)^{2} x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+}$.
The first three terms on the right-hand side are contained in $U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+}$, so we consider

$$
\left(x_{2}^{+}\right)^{2} x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} \approx\left(x_{2}^{+}\right)^{2} x_{1}^{+} x_{2}^{+}\left(x_{1, \pm 1}^{+} x_{2}^{+}+x_{2, \mp 1}^{+} x_{1}^{+}+x_{1}^{+} x_{2, \mp 1}^{+}\right) .
$$

Now

$$
\begin{aligned}
\left(x_{2}^{+}\right)^{2} x_{1}^{+} x_{2}^{+} x_{1}^{+} x_{2, \mp 1}^{+} & \approx\left(x_{2}^{+}\right)^{2}\left(x_{1}^{+}\right)^{2} x_{2}^{+} x_{2, \mp 1}^{+}+\left(x_{2}^{+}\right)^{3}\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+} \\
& \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+},
\end{aligned}
$$

hence

$$
x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) \cdot x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) \cdot x_{1}^{+} .
$$

It follows that

$$
x_{2}^{+} x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0,
$$

and so $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\mu+\theta}^{+}$, as required.

Now suppose that $x_{1, \pm 1}^{+} \cdot v \neq 0$ and $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0$. Since

$$
x_{2}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}=\left(x_{2}^{+}\right)^{4} x_{1, \pm 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}
$$

we have

$$
x_{2}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0
$$

This implies that $\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\mu+3 \alpha_{2}+\alpha_{1}}^{+}=0$ by assumption, hence

$$
\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+} \cdot v=0
$$

Now consider

$$
\begin{aligned}
x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} & \approx x_{1}^{+} x_{2}^{+} x_{1}^{+} x_{2, \mp 1}^{+} \\
& \approx\left(x_{1}^{+}\right)^{2} x_{2}^{+} x_{2, \mp 1}^{+}+x_{2}^{+}\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+} \\
& \approx\left(x_{1}^{+}\right)^{2} x_{2, \mp 1}^{+} x_{2}^{+}+\left(x_{2}^{+}\right)^{2}\left(x_{2}^{+}\right)^{2}+\left(x_{2}^{+} x_{1}^{+}\right)^{2} \\
& \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+} .
\end{aligned}
$$

So $x_{1}^{+}\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} \cdot v=0$ which gives

$$
\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\mu+2 \alpha_{2}+\alpha_{1}}^{+}=0
$$

and so

$$
\left(x_{2}^{+}\right)^{2} x_{1, \pm 1}^{+} \cdot v=0
$$

Next, consider

$$
\begin{aligned}
x_{1}^{+} x_{2}^{+} x_{1, \pm 1}^{+} & \approx x_{1}^{+} x_{1, \pm 1}^{+} x_{2}^{+}+x_{1, \pm 1}^{+} x_{1}^{+} x_{2}^{+}+x_{2}^{+} x_{1}^{+} x_{1, \pm 1}^{+}+x_{2}^{+} x_{1}^{+} x_{1, \pm 1}^{+} \\
& \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{1}^{+} .
\end{aligned}
$$

So $x_{1}^{+} x_{2}^{+} x_{1, \pm 1}^{+} . v=0$ which gives

$$
x_{2}^{+} x_{1, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\mu+\alpha_{2}+\alpha_{1}}^{+}=0
$$

and so

$$
x_{2}^{+} x_{1, \pm 1}^{+} \cdot v=0 .
$$

Finally, consider $x_{1}^{+} x_{1, \pm 1}^{+}$. Since this $\in U_{q}(\hat{\mathfrak{g}}) x_{1}^{+}$, we have

$$
x_{1}^{+} x_{1, \pm 1}^{+} \cdot v=0,
$$

so that $x_{1, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\mu+\alpha_{1}}^{+}=0$, which implies that $x_{1, \pm 1}^{+} \cdot v=0$. This completes the proof of Lemma 4.5.

Proposition 4.6 Let $V(\mathbf{P})$ be a minimal affinization of $\lambda \in P^{+}$with the roots of $P_{1}$ forming a $q^{2}$-segment with inverse centre $a$. Then:
(i) $m_{\lambda-n \theta}(V(\mathbf{P}))=1$ for $0 \leq n \leq r$;
(ii) $m_{\mu}(V(\mathbf{P}))=0$ if $\mu$ is of the form $\lambda-n \theta-\left(\alpha_{1}+\alpha_{2}\right)$ for some $n \in \mathbb{N}$.

Proof. Both parts are proved by induction on $n$. The $n=0$ case is proved in [2]. Assume that (i) and (ii) are proved for all integers $\leq n$.

Suppose that $m_{\lambda-(n+1) \theta}(V(\mathbf{P}))>1$. By Lemma 4.5, the action of $x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, \pm 1}^{+}$ defines a map

$$
V(\mathbf{P})_{\lambda-(n+1) \theta}^{+} \rightarrow V(\mathbf{P})_{\lambda-n \theta}^{+} .
$$

By the induction hypothesis, $m_{\lambda-n \theta}(V(\mathbf{P}))=1$ so this map has a non-zero kernel. This implies that there exists $0 \neq v \in V(\mathbf{P})_{\lambda-(n+1) \theta}^{+}$such that

$$
x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1,1}^{+} \cdot v=0
$$

which, by Lemma 4.5, gives $x_{1,1}^{+} \cdot v=0$.
Suppose now that $x_{1,-1}^{+} \cdot v \neq 0$ and, for $s=0,1, \ldots, n+1$, define $v_{s} \in V(\mathbf{P})$ by

$$

x_{2}^{+} x_{1}^{+} x_{2, \pm 1}^{+} \cdot v=0 .
$$

But clearly,

$$
\left(x_{1}^{+}\right)^{2} x_{2, \pm 1}^{+} \cdot v=0
$$

so

$$
x_{1}^{+} x_{2, \pm 1}^{+} \cdot v \in V(\mathbf{P})_{\lambda-(n+1) \theta}^{+} .
$$

This proves (13). To prove (14), we have from [2, p. 910],

$$
\left(x_{2}^{+}\right)^{2} x_{1, s}^{+} x_{1}^{+} x_{2, \pm 1}^{+} \in U_{q}(\hat{\mathfrak{g}}) x_{2}^{+} x_{1}^{+} x_{2, \pm 1}^{+}+U_{q}(\hat{\mathfrak{g}}) x_{2}^{+} x_{2, \pm 1}^{+}
$$

for $s= \pm 1$. So, in particular,

$$
x_{1}^{+}\left(x_{2}^{+}\right)^{3} x_{1, s}^{+} x_{1}^{+} x_{2, \pm 1}^{+} \cdot v=0
$$

Let $w=x_{1}^{+} x_{2, \pm 1}^{+} \cdot v$. Then,

$$
x_{1}^{+}\left(x_{3}^{+}\right)^{2} x_{1, s}^{+} \cdot w=0 .
$$

Lemma 4.5 now implies that

$$
x_{1, s}^{+} \cdot w=0 .
$$

This completes the proof of Proposition 4.6.
The following theorem is an immediate consequence of Proposition 4.6.

Theorem 4.7 Let $\mathfrak{g}$ be of type $G_{2}, r \geq 0, \lambda=r \lambda_{1}+\lambda_{2} \in P^{+}$and $V(\mathbf{P})$ a minimal affinization of $\lambda$. Then, as a $U_{q}(\mathfrak{g})$-module,

$$
V(\mathbf{P}) \cong \bigoplus_{j=0}^{r} V_{q}\left(\lambda-j \lambda_{1}\right)
$$
