

## **CONDITIONS OF PUBLICATION CONCERNING THE ARTICLES WHICH WILL BE PUBLISHED ON TRAKYA UNIVERSITY JOURNAL OF SCIENTIFIC RESEARCH SERIES OF SOCIAL SCIENCES**

The articles are published on the Trakya University Journal of Scientific Research Series of Social Sciences in the framework of Trakya University Journals Concerning the General Principals.

1. In the journal original articles are required which is not being submitted for publication elsewhere and not given any copyrights.

2. Any kind of responsibility of the articles which will be published on the journal is belong to the writer.

3. Articles should be typed 1,5 line spaced according to the Word 6 programme on the one side of the paper with the 12 font size ( True Times New Roman ) and sent to the editor in two copies with the disk. Articles should not exceed 10 pages if not they may not published on the journal and unpublished articles are sent back to the writer.

4. Title of the article is written with capital letters starting from the left top of the page by leaving 6 cm empty space. Name/names of the writer is written right bottom of the title side by side. Any kind of academical title of the writer is not written while writing the name/names of the writer. Academical title of the writer, Institution where he/she works ( university, faculty, department or others ) are written as footnotes at the bottom of the page.

5. Summary in Turkish is written just after the title and names of the writers. Summary is written with capital letters in the middle of the page. Turkish summary of the subject can not exceed 200 words. After summary in Turkish, summary in foreign language must be take part which it was written in one of the languages of the Associated Professorships ( English, French, German or Italian ) , Key words are given at the bottom of the pages in both summaries in the same languages. If the work is materialized with the support of an institution its name is given at the bottom of the first page as a footnote. Original name of the article is written below the SUMMARY title with small letters.

6. Articles in the field of research and examination are submitted according to the order which is mentioned below. SUMMARY, INTRODUCTION, PROBLEM, AIM AND PURPOSE, LIMITATIONS (If is needed) , HYPOTHESIS ( If it is needed), METHODS, COMMENTS, RESULTS, DISCUSSION, ACKNOWLEDGEMENTS (If it is needed ).

References

7. There is no compulsion in the presentations of the new discovery and technique as in the 6th article. They can be sent in the correct order in connection with their original situation. Board of editors can make some changes in such articles by consulting to the writer.

Explanatory Footnotes

8. Explanatory footnotes are mentioned at the same page consecutively by numbering at the bottom of the page.

Connective References

9. References which is quoted must be given in the text with the connective references according to the technique of " writer and year " , surname of the writer, publishing date and page number.

If the name of the writer is mentioned in the text, year of the references must be written in brackets.

Example: Yildirim ( 1996) ... or by giving the page number, Yildirim (1996: 70-97).

Example: New developments have been made in this field. ( Raths, 1967: 40-85)

Example: Gates (1967a : 45-50( 1967b : 130-170) .

If the references have two writer only their surnames are written.

Example: Massialas and Cox (1967: 37-66)

If the two writers have the same surname and their works which were published at the same year can be distinguished by the first letter of their names.

Example: Smith, O. and Smith, B. (1958: 251-251)

If the reference has more than two writer all surnames are mentioned in the first mentioning.

Example: Bursalioglu, Aydin, Kaya, (1995: 120-145)

In the next mentioning et al. is used.

Example: Bursalioglu, et al. (1995: 120-145)

The references which are given as a line should be ordered from the oldest date to the recent one and must be separated with semicolon in the brackets.

References

Reference list can be given in this order ( surname of the writer , first letter of his/her name , publishing date ( in brackets), name if there is, number of volume, number of edition and page number. Second line is written 3 letter intended from the first line. All references which are used in the article should be given in alphabetical oeder on a separate page at the end of the writing. If more than one work of a writer are used as references they should be given from the oldest to the recent one.

Books : Surname of the writer, name. Publishing date ( in brackets) . Title of the book ( in Italic) , Place of publishing: Printing House

Example: Bloom, Benjamin S. (1967) *Human Characteristics and School Learning*, New York : MC Graw- Hill Company.

Journals : Surname of the writer , name. Year ( in brackets) Title of the Article ( in quotation marks) , Name of the journal (in Italic) , number of volume, number of edition or month: pages.

Example : Ericson, L.H. (1958) "

Selecteds : Surname of the writer , name . Year ( in brackets) Title of the article ( in quotation marks), Name of the editor and (ed.) or (eds.) , name of the book

Selecteds : Surname of the writer , name . Year ( in brackets) Title of the article ( in quotation marks), Name of the editor and (ed.) or (eds.) , name of the book

( in italic) , Place of Publishing : Printing House .

Example : Getzels, J.W. (1958) " The Aquisition of Value in School and Society " , F.S. Chase and H.A.Anderson ( eds.) *The High School in the New Era* , Chicago: University of Chicago Press.

Pictures, figures, graphs belong to the articles which will sent must be clear and suitable for the teqnique of offset printing and should not exceed the area off writing . Their row number and names are given below the each figure or graph.
