This article will focus on the strategic management of sports science faculties. Strategic management plays a crucial role in defining the faculties' goals, managing resources, and sustaining long-term success. This study aims to emphasize the significance of strategic management in Sports Science Faculties, addressing the goals, challenges, and future vision in this domain. The statistical analysis of the article is based on the data provided on the webpage of the Sports Science Faculty at Burdun Mehmet Akif Ersoy University. Through a SWOT analysis, the results have beer examined. According to the obtained results, the strong aspects include extensive facilities, diverse sports areas and classrooms, health units, and a performance laboratory, reflecting professional services. However, for the institution to compete in a competitive environment and keep up with technological advancements, more resources and capabilities are required. Innovative practices and emphasizing the impact of sports on public health represent opportunities for the institution. The challenge of keeping educational programs current and effective in the face of rapidly changing technological and societal conditions is among potential threats. Therefore, leveraging the institution's strengths to capitalize on opportunities and addressing weaknesses and threats is crucial.

In this context, the strategic management of these faculties shapes their future successes, considering both their internal dynamics and general trends in the field of sports (Baregheh et al., 2009).

The strategic management of sports science faculties is gaining increasing importance in the literature. Previous studies in this field emphasize the significance of clearly defining the missions and visions of faculties, gaining a competitive advantage at national and international levels, and focusing on long-term goals (Abbasi et al., 2009; Jones et al., 2020).

What is Strategy? Strategy is the collection of ways and plans an organization establishes to achieve its long-term goals. Strategy assesses the internal and external environment of an organization, aims to use resources most efficiently, and seeks to gain a competitive advantage (McLaughlin, 2000).

What is Strategic Management? Strategic management is the process of defining, implementing, and monitoring an organization's strategic objectives. This process involves determining the mission, vision, objectives, and goals of the organization, making plans to achieve them, and managing resources (Acar and Akçakaya, 2023; Baregheh et al., 2009).

Key Stages of Strategic Management:

Analysis Stage: This is the stage where the organization's internal strengths and weaknesses, as well as external opportunities and threats, are evaluated. SWOT analysis (Strengths, Weaknesses, Opportunities, Threats) is an integral part of this stage (Barnabè, 2011).

Strategy Formulation: Based on the analysis results, the organization's mission, vision, and goals are determined. This is the stage where strategic objectives, plans, and projects are created (Bryson, 2018).

Strategy Implementation: This is the stage where the formulated strategies are put into practice. This stage involves resource allocation, organizational structuring, and making operational plans (Dowling et al., 2014).

Monitoring and Control: The results of the implemented strategies and the status of achieving the objectives are regularly monitored and evaluated. Corrective measures can be taken if necessary (Nejatian and Zarei, 2013).

Importance of Strategic Management:

- Strategic management provides an organization with a roadmap toward its purpose.
- It ensures the effective and efficient use of resources.
- It assists in gaining and sustaining a competitive advantage.
- It facilitates adaptation to changing market conditions.
- It promotes a culture of collaboration and teamwork (Corte, 2013).

Strategic Management in Physical Education and Sports: In the field of physical education and sports, strategic management refers to the management approach that aims to determine long-term goals, efficiently utilize resources, gain a competitive advantage, and promote the spread of sports through sports institutions and organizations (Boutroy et al., 2015).

Why Strategic Management? Strategic management is suitable for the field of physical education and sports due to rapidly changing conditions, a competitive environment, and societal demands. Sports organizations require strategic planning to define their goals, ensure efficient resource utilization, and extend sports to all segments of society (Coontz, 2001).

Concepts of Strategic Management in Sports Organizations: Defining Mission and Vision: Sports organizations should clearly define their mission and vision to express why they exist and where they aim to go (Desbordes, 2001).

SWOT Analysis: Sports organizations can shape their strategies by assessing their internal strengths and weaknesses, as well as external opportunities and threats (Acar and Akçakaya, 2023).

Goal Setting: Sports organizations can establish long-term goals and create intermediate goals and measurable objectives to achieve them (Ringuet-Riot et al., 2014).

Resource Management: Sports organizations should strive to achieve their goals by efficiently utilizing limited resources (financial, human resources, time, etc.) (Dulakahoria and Jana, 2013).

Competition Strategies: Sports organizations can develop strategies to gain and sustain a competitive advantage over their competitors (Desbordes, 2002).

Importance of Strategic Management in Physical Education and Sports:

Physical education and sports are not only integral to physical health but also to psychological, social, and mental well-being. This field aims to enhance individuals' quality of life, develop athletes' skills, promote social interaction, and improve overall health (Acar, 2015). Therefore, implementing strategic management in physical education and sports holds great significance. Here are some explanations regarding the importance of strategic management in physical education and sports:

Goal Setting and Attainability: Strategic management serves as a crucial tool to reach set goals in the field of physical education and sports. Defining accurate and clear objectives helps align all stakeholders towards the same direction. Social Impact: Physical education and sports serve as significant tools influencing the overall health, lifestyle, and values of society. Strategic management supports enhancing the social impact of sports and reaching a broader audience (Acar et al., 2016).

Innovation and Development: Strategic management encourages the continuous tracking and implementation of new ideas and developments. As a result, the latest scientific findings and best practices in physical education and sports can be swiftly adopted (Yoshida et al., 2013).

In conclusion, strategic management in physical education and sports plays a critical role in achieving goals, effectively utilizing resources, gaining a competitive advantage, ensuring long-term sustainability, and creating social impact. The strategic management approach offers an opportunity to build a more organized, higher performing, and successful future for all stakeholders in this field.

Methods

This analysis is employed to comprehend the internal and external environments of the organization, gain competitive advantages, and achieve future objectives. While strengths and weaknesses reflect the internal dynamics and capabilities of the organization, opportunities and threats mirror external environmental conditions and competitive factors. SWOT analysis is utilized in the strategic planning process to assess the current state of the organization and determine future actions.

Considering the aim of being a respected institution at the national and international levels, insufficient international collaboration and network building can be evaluated as a potential weakness. While focusing on various sports fields and disciplines is indicated, a lack of deeper specialization or a more focused expertise area could be considered as a potential weakness. In terms of the Relationship between Education and Research, while it is emphasized that education and research should support each other, the inability to effectively manage this relationship or achieve a balance can be a potential weak point. These potential weaknesses can be considered as areas requiring more detailed analysis. Identifying these weaknesses and shortcomings is important for shaping the institution's development strategies and improvement plans (Table 2).

Developing effective strategies and plans to manage and overcome these threats is of critical importance to ensure the institution's attainment of its objectives (Table 4).

These weaknesses may reflect deficiencies in your sports and training center that could potentially lead to customer attrition (Table 6).

The analysis results reveal that among the threats to the Faculty of Sports Sciences, competition is a significant factor. The necessity to differentiate and provide quality-focused services to compete with other sports centers and facilities is evident. Fluctuations in demand represent another threat. Given the potential changes in demand due to seasonal and economic fluctuations, this aspect should be carefully considered. Furthermore, during ongoing educational activities, the preferences of sports teams prioritizing camp and sports activities could lead to a decline in educational quality. In addition, inadequate infrastructure and capacity issues may have adverse effects on service quality (Table 8).

Conclusion

SWOT analysis is a systematic strategic management tool used to evaluate the strengths, weaknesses, opportunities, and threats of an organization or project. In the context of sports science faculties, its strategic management is of critical importance in educating future sports professionals and providing leadership in the field of sports. By enhancing strengths and addressing weaknesses, faculties can become pioneers in the sector by delivering more effective education and research. The SWOT analysis results concerning sports facility capabilities reveal that its strengths encompass a broad range of facilities, diverse sports areas and classrooms, health units, and a performance laboratory, all of which constitute professional services. These strengths can augment the center's capacity to host activities targeting various age groups and sports disciplines. Among the weaknesses, issues such as distance from the city center, transportation problems, and overlooking environmental factors like wind and meteorological fluctuations in facility projects are evident. Opportunities lie in the availability of capacious hotel rooms, diverse sports areas and classrooms, and the potential to host collective events. Additionally, the prospect of accommodating health and sports-focused activities stands as a significant opportunity. The presence of competition is identified as a threat. To compete with other sports centers and facilities, differentiation and the provision of quality-focused services are necessary. Fluctuations in demand constitute another threat, where changes in demand due to seasonal and economic fluctuations should be taken into account. Preferences for team camps and sports activities may prioritize demands over educational activities, potentially affecting educational quality. Moreover, inadequate infrastructure and capacity issues can negatively impact service quality.

Regarding the SWOT analysis conducted based on the institution's mission and vision statement, it is evident that the Faculty of Sports Sciences has established a solid foundation in terms of core values, teaching approach, and objectives. These values underscore the institution's aspiration to attain a pioneering position in the field of sports by embracing a contemporary mindset. The goal of emphasizing the significance of sports for public health reflects the institution's mission to contribute to society.
