

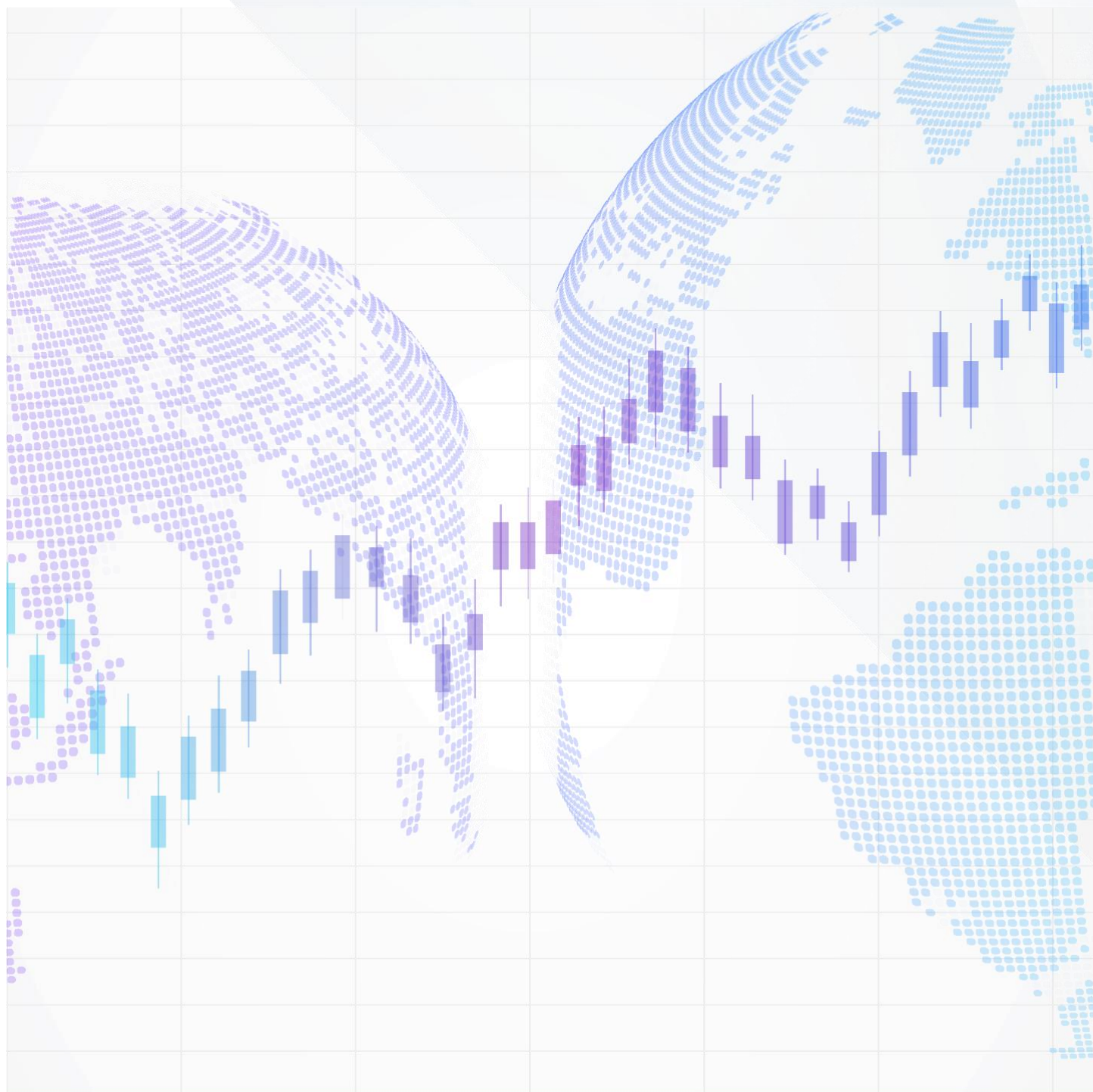

JOINBAT – Journal of Business and Trade is in the category of peer-reviewed, online and open access international journal published by Sakarya University of Applied Sciences (SUBU) Scientific Publications Coordinatorship (BIYAK). The journal started its publication life with its first issue on December 31, 2020, and is published twice a year (June/December) as an e-journal.

JOINBAT accepts publications in Turkish or English. It publishes original research articles, review articles, and case reports in areas including Finance, Marketing, Human Resources Management, Accounting and Auditing, Management and Organization, and Banking. The journal may also include classic foreign article translations and book reviews in these fields when deemed necessary. Articles outside the journal's scope may be rejected by the editorial board.

All submitted articles undergo a double-blind peer-review process. Therefore, at the initial submission stage, no information that may reveal the authors' identity should be included either in the manuscript or in the file name. The article evaluation process takes approximately two months. The deadline for article submission is May 15 for the June issue and November 15 for the December issue.

JOINBAT adopts an open access policy, aiming to freely disseminate national and international developments in its fields of interest. In accordance with the TR Index criteria, for studies requiring an Ethics Committee Approval, the related document must be uploaded to the system during submission. Additionally, all required submission documents must be provided; otherwise, the manuscript will be rejected.

JOINBAT is committed to advancing multidisciplinary knowledge in the business and trade disciplines and provides a platform for scholars, practitioners, and policymakers to share their insights without any publication fees.
