

# Terör Tipolojileri Üzerine Bir Literatür Taraması

## ABSTRACT

**A Literature Scanning on the Terror Typologies.** *The literature on religion and violence, or terror was already substantial before the September 11 attacks, and it has swelled at an increased pace since then. I have not seen abundant evidence, however, that the serious reflections on violence expressed in these books has made a noticeable impact on the shape of higher education, on news media reporting, or on the thinking of government officials around the world. This bibliography provides information sources about terrorism, terrorist groups and the terror typologies. It is not comprehensive and only a starting point, since the situation is changing daily. Many of the books could have legitimately been listed in more than one of the subsections below, which highlights the somewhat artificial nature of the categories I have set up. I appended to each subsection below subject headings that will enable the reader to explore the topic further as well.*

## Giriş

Terör, yeni bir olgu olmadığı halde, 11 Eylül saldırılarıyla birlikte bütün dünyanın daha yakından tanıdığı bir kavramdır. Öyleki, 1977-2001 yılları arasında terör içerikli 11.415 eylem gerçekleştirilmiştir. Bu zaman diliminde meydana gelen olayların sayısında periyodik bir azalma gözlenmekle birlikte, sonuça ortaya çıkan tahribatin ve özellikle ölüm oranlarının giderek attığı görülmektedir. Zamanla terörün doğası değişmiş, eylemleri daha ölümcül hale gelmiştir. 1990 öncesinde pek çok terör organizasyonu bir taraftan uluslararası medyanın dikkatini çekecek, diğer taraftan kamuoyunun desteğini alacak bir tarzda gündeme uygun politik hedefler seçerken, yakın zamanda gerçekleştirilen saldırıların maksimum tahribata yol açacak şekilde planlandığı görülmektedir. 1998'de Dünya Ticaret Merkezi ve Pentagon'a düzenlenen saldırıların yanı sıra, Nairobi ve Darüsselem'da kalabalık kent merkezlerindeki Amerikan elçiliklerine yapılan saldırıarda 300'den fazla kişi olmuş ve 5000'den fazla kişi de yaralanmıştır. Benzer amaçlarla gerçekleştirilen

riilen başka saldırular da olmuştur: 1993'te New York'ta Linkoln ve Hollanda tünelerine düzenlenen ve başarısızlıkla sonuçlanan saldırular, 1995'te 11 Amerikan uçağının Asya'ya kaçırılması ve nihayet 1999'da Kanada sınırlında tescüfü bir tutuklama sonucu ortaya çıkan milenyum planı bunlar arasındadır. Bununla birlikte, bu olaylar hakkındaki söylem, bu tür saldıruların nedenlerini sorgulama ya da işbirlikçilerini aramanın çok daha ötesine uzanmaktadır. Bu tavrı, farklı kültürleri ve bölgeleri tanımlamaya çalışan çok daha geniş kapsamlı Batılı söylemin sadece bir parçasını oluşturmaktadır. Aslında, terörizm, Batının dışında kalan bazı bölgelerin risk bölgeleri olarak tanımlanmasına temel oluşturan uzun ve tehlikeli koşullar zincirinin en son halkasıdır.<sup>1</sup>

Günümüzde küreselleşmenin kitle iletişim ve ulaşım alanlarında sunduğu imkanları kullanan terör örgütleri ve destekçileri, dünyanın çeşitli bölgelerinde birbiri ardından gerçekleştirdikleri eylemlerle dünya gündemini her geçen gün daha fazla meşgul etmeye devam etmektedir. Terörün kamusal görünürüğünün kitleleri teröre edebeceğini ve teröristlerin taraftar toplamak amacıyla medyanın sunduğu propaganda imkanlarını kullanabileceğini savunan bazı yazarlar, terör içerikli haberlerin halkın demoralize olmasına yol açabileceğine işaret etmektedirler. Bununla birlikte, günümüzde özellikle görsel ve yazılı medyaya yansayan sosyal içerikli pek çok sorunu tanımlamak için kapkaç terörü, trafik terörü ve hatta gıda terörü gibi ifadelerin kullanıldığı bilinmektedir. Geniş kitleler üzerinde ortaya çıkardığı yıkıcı etkilerle günümüzün değişmez gündemleri arasında giren kitlesel terör eylemlerinin yanı sıra, yeni terör tanımlamalarının kamuoyunda bir tür terör fobisi ne yol açtığı, en azından bu olasılığın her geçen gün güçlendiği görülmektedir.

*Terör nedir? Terörün başlıca unsurları nelerdir? İnsanlar niçin terörist eylemler gerçekleştirmektedir? Terörün beslendiği kaynaklar nelerdir? Teröristler eylemlerini nasıl planlamakta ve gerçekleştirmektedirler? Toplumsal, siyasal ve iktisadi faktörlerin terör üzerindeki etkileri nelerdir? Siyasi yönetimler terörizmle nasıl mücadele edebilir? Terörist grupların başlıca özellikleri nelerdir?* gibi daha pek çok sorun bu çerçevede tartışılmak durumunda kalmaktadır.

Bu araştırmanın amacı, yukarıda tasvir edilen temel nitelikleri ile günümüzde çeşitli boyutlarıyla çok tartışılan kavramlardan biri haline gelen/getirilen terör fenomeni hakkında ilgili okuyucuya uluslararası literatürde yayımlanmış bazı makale ve kitapların bibliyografik künnyelerini tanıtmak ve bu sayede konu ile ilgili yayılara erişim kolaylığı sağlamaktır. Elbette, ekonomiden dine, hukuktan iletişime ve politikadan uluslararası ilişkilere kadar çok geniş bir alanı içine alan böylesine kapsamlı bir literatürü, sadece bibliyografik künnyeleri ile bile olsa, bütünüyle tespit etmek imkan dahilinde değildir. Bu nedenle, araştırmada, öncelikle terör tartışmalarının odaklandığı belli başlı alanların ve bu alanlardaki temel tezleri ve tartışmaları ortaya koyan eserlerin tespiti amaçlanmıştır. Böylece, terör/terörizmin kuramsal ve toplumsal boyutlarının (devlet, din, medya, hukuk, siyaset, güvenlik ve ide-

oloji) yanı sıra, biyolojik, nükleer, kimyasal ve siber terör gibi çeşitleri ile ilgili başlıca yayınlar belirlenmeye çalışılmıştır. Bu belirlemedeki temel kriter, terör tartışmalarının farklı tipolojilere konu olacak düzeyde bir çok yönlülüğe sahip olmasıdır. Ayrıca, eserlerin bibliyografik kütüyeleri verilirken yazarların soyadlarına göre bir sıralama takip edilmiştir. Konu ile ilgili olarak testpit edebildiğimiz yayınlar şunlardır:

### Sonuç Yerine

Batıda üretilen terör/terörizm söyleminin, Batının batılı ol(a)mayan dünya ile ilgili köklü önyargı ve korkularından kaynaklanan sürekli bir olgu olduğu, artık yadsınamaz bir gerçektir. Bununla birlikte, bu yeni olguya özgü farklı niteliklerden söz edilebilir. Özellikle batılı medya, kültürel anlamda İslamiyet'in önemli bir parçasını oluşturduğu dünyadan belli bölgelerinde komşu kültürler arasındaki tarihsel düşmanlığı yeniden canlandırmaya çalışarak Müslümanlarla, özelde Hristiyanlar ve genelde diğer din mensupları arasında karşılıklı güvensizliğe dayalı yeni bir dünya senaryosu üretme gayırtı içinde görülmektedir. Yukarıda listelemeye çalıştığımız eserlerin büyük bölümü çoğunlukla bu bakış açısıyla kaleme alınmıştır. Başka bir ifadeyle, Batı (özellikle ABD) 11 Eylül öncesinde "risk bölgeleri" olarak tanımladığı bölgeleri artık kendi güvenliği ve geleceği açısından "tehdit bölgeleri"<sup>22</sup> olarak nitelendirmekte ve dünya kamuoyunu (hatta kendi vatandaşlarını) yanlış bilgilendirmeye ve yaniltmaya devam etmektedir. Elbette, terörün meşrulaştırılabilecek hiçbir boyutu olamaz. Ancak, son yıllarda Afganistan ve Irak başta olmak üzere dünyanın çeşitli bölgelerinde yaşanan şiddet olayları, terörün ya da teröristin tanımı ve kimliği konusunda zihinleri bulandırmaya devam etmektedir. Öyle görünüyor ki, burada sadece konu başlıklarıyla küçük çaplı bir tipolojisini vermeye çalıştığımız terör olgusu, önümüzdeki yıllarda da gündem oluşturmaya ve çokça tartışılmaya devam edecektir.
