



Dünya'da Fiziki /Biyolojik Antropoloji ve Adli Antropoloji'nin en büyük ve en etkili isimlerinden biri olan, Türk bilim insanı Prof. Dr. Mehmet Yaşar İşcan hakkında yazı yazmaya, Ankara Üniversitesi, Dil ve Tarih-Coğrafya Fakültesi, Antropoloji Bölümü, Paleoantropoloji Anabilim Dalı Başkanı Prof. Dr. Ayla Sevim Erol tarafından davet edilmiş olmaktan şeref duymaktayım. Prof. Dr. Mehmet Yaşar İşcan, bana hocası Prof. Dr. Wilton Marion Krogman'ın ardından yazılan makalelerden söz etmişti (Stewart, 1973; İşcan, 1988; İşcan, 1991), ancak o dönemde İşcan hocamızın

seçkin kariyer yaşamı hakkında bir gün benim de yazı yazacağımı düşünemeydim.

Prof. Dr. Mehmet Yaşar İşcan, 17 Şubat 1943 yılında Kahramanmaraş'ta tanınmış Eşbah soyundan gelen, asker kökenli bir ailinin 5. çocuğu olarak doğmuş. Vecihe, Nazire ve Muammer¹ isimli üç ablası, Doğan adında bir ağabeyi vardır. Gar Şefi olan babası Mustafa İşcan'ın görevi nedeni ile üniversite öncesi eğitimini Maraş, Elazığ ve Adapazarı gibi çeşitli illerimizde yapmıştır. Onceleri veteriner hekim olmak isterken, sonradan 8. tercihi olan antropoloji bilim dalını seçmiştir. Üniversite lisans eğitimini Ankara Üniversitesi, Dil ve Tarih-Coğrafya Fakültesi bünyesinde 1968 yılında bitirip, 1969 yılında Amerika'ya gitmiştir. Amerika'da önce Smithsonian Enstitüsü'nde çalışmış, Yüksek Lisans eğitimi için New York Cornell


Üniversitesi'ne gitmiştir. Doktora sonrası

Atlantic Üniversitesi'nin yayınladığı gazetenin "İşcan tarafından çalışan cesetler. Ölüler de konuşur" başlıklı haberinde; Yaşar İşcan'ın uzmanlık alanının ceset incelemesi olduğu ve polis teşkilatı çalışmaları ile ilgili olduğu belirtilmiştir. Boca bölgesinde sadece 3 ay gibi kısa bir zamanda bölge polisi tarafından kendisine getirilen kemik setlerini incelemiş olduğu bildirilmiştir (Atlantic Sun 5 Nisan, 1977).

Prof. İşcan üniversite mezunlar toplantısında, insan ve çevrebilim [human ecology] uzmanı olan ve ileri yıllarda Buffalo Üniversitesinde Profesör öğretim üyesi olarak görev yapacak olan, Dr. Walda E. İşcan ile tanışıp, 1976 yılında evlenmiş ve 1978 yılında, Prof. İşcan'ın annesi Ayşe Hanımın adını verdikleri, Ayşe Meryem isimli kızları dünyaya gelmiştir. İşcan çifti kızları ile ilgilenebilmek için farklı saatlerde çalışmışlardır (Resim

Prof. Dr. İşcan kariyerinin 30 yılını Amerika'da geçirmiştir, Amerika, Şili, Arjantin olmak üzere birçok toplu mezarda bilirkişi olarak görev yapmıştır, birçok davada görüşlerine başvurulmuştur, bilirkişi olarak girdiği birçok davada, sanıkları elektrikli sandalyeden kurtarmıştır (Müjgan Halis 2013). Prof. İşcan Adli antropolojinin, adli bilimlerin ayrılmaz bir parçası olduğunu ve biyolojik antropolojinin bilimsel gelenegini izlediğini söylemiştir. Adli antropolog olarak; ABD, Mississippi'de ırkçı Ku Klux Klan örgüt üyeleri tarafından, 27 Ağustos 1955 tarihinde, 14 yaşındayken öldürülən Emmett Louis Till'in dosyası gibi birçok esrarengiz olayı

aydınlatmıştır² (Önay Yılmaz 2003). Kariyerinin son döneminde, 1999 yılında İstanbul Üniversitesi Adli Tıp Enstitüsü'nde öğretim üyesi olarak görevye başlamış ve bu enstitüden emekli olmuştur.

Prof. Dr. İşcan uluslararası mesleki derneklerin oluşturulmasına, kongre, toplantı, proje ve çalıştayların gerçekleştirilemesine, böylece mesleki dostluk ve dayanışmanın da geliştirilmesine çok önem verirdi. Örneğin ilk "Dental Antropoloji Derneği", 1986 yılında, Amerikan Fiziki Antropologlar Birliği'nin New Mexico'da gerçekleşen yıllık toplantılarında Prof. Dr. Mehmet Yaşar İşcan'ın önerisi ile kurmuştur (Kelly ve Larsen, 1991). Aynı şekilde Balkan Adli Bilimler Akademisi'nin (Balkan Academy of Forensic Sciences – BAFS) kuruluşunu da Prof. İşcan sağlamıştır. Girit'in Heraklion şehrinde, 6-10 Kasım 2002 tarihleri arasında gerçekleştirilen 3rd Pan Hellenic Congress on Forensic Science and Toxicology kongresi sırasında, Türkiye ile Balkan ülkelerinden gelen bir grup bilim insanını, başkanlığını yaptığı Candia Maris Toplantısında görevlendirek, Balkan Adli Bilimler Akademisi'ni kurdu (Resim 4).

Bu kuruluşun ilk kongresi 2003 yılında İstanbul'da, daha sonraki kongreleri sırasıyla; Yunanistan, Romanya, Bulgaristan, Makedonya, Arnavutluk, Kosova gibi çeşitli Balkan ülkelerinde gerçekleştirildi. Bu kongrelerde benim de dahil olduğum uluslararası projeler yapılmıştır. İlk olarak 2004 yılında, Poros Arkeoloji Müzesinde Miken (Mycenaean) uygarlığına ait, iskelet ve dental kalıntıları üzerinde çalıştık, bu konuda alınan sonuçlar üzerine makalelerimiz yayınlandı ve kongrelerde sunumlar yapıldı (İşcan vd., 2007; Kranioti vd., 2013).

okuyucu için kolay ulaşılacak değerli bir kaynak olacağını söyleyerek, bu nedenle kendisi bir çok derginin *Forensic Anthropology* özel sayılarını yayımlamıştır³ (İşcan, 1998; İşcan, M.Y. 2001). Ayrıca dış antropolojisi konusu ile ilgili olarak hem *American Journal of Physical Anthropology* dergisinin hem de *Adli Bilimler Dergisi*'nın Mart 2007 özel sayısını yayımlamıştır (İşcan, 1989; İşcan ve Aka, 2007).

Prof. Dr. İşcan Adli Antropoloji ve Adli Odontoloji uzmanlarının; baş, yüz ve çene kemikleri ile dişlerin morfolojisinde, bir takım halinde çalışmalarını önermişti. Bu öneri üzerine ekip olarak çeşitli toplumların biyolojik özelliklerini, antropometrik ve odontometrik yöntemlerle araştırdık, adli kimliklendirilme konusunda ulusal ve uluslararası düzeyde disiplinlerarası kooperasyonla proje ve çalışmalar yürüttük, sonuçlarını yayınladık, kongre ve çalıştaylarda bildirilerini sunduk (Resim 5) [İşcan ve Kedici, 2003; Aka (Kedici) ve İşcan, 2004; Jasuja, Aka, Gagan vd., 2011].

İşcan hocamız adli kimliklendirilme amacı ile Yüz Antropolojisi (*Facial Anthropology*) ve Adli Yüz Yapılandırma (*Forensic Facial Reconstruction*) alanında da çalışmalarımızı desteklemiştir. Benim, Protetik Diş Tedavisi Anabilim Dalı öğretim üyesi olmam (Ankara Üniversitesi, Diş Hekimliği Fakültesi, Protetik Diş Tedavisi Anabilim Dalı 1993 Profesörü), heykel sanatında Yüksek Lisans Derecesi almış olmam (Gazi Üniversitesi, Heykel Anasınat Dalı, Yüksek Lisans 2000) ve Gazi Üniversitesi'nde 7 yıl heykel atölye çalışması yapmış bulunmam nedeniyle geliştirmiş olduğum el becerim ve malzeme bilgimin, bu konuda yararlı olacağını belirterek, beni adli yüz yapılandırma konusunda çalışmam için cesaretlendirmiştir. Bu konuda geliştirdiğimiz yeni bilimsel tekniklere da destek vermiş, Prof. Dr. Ayhan Gürbüz ile beraber ürettiğimiz polyester yüz ölçüsü kalıbı ile kendi yüz ölçüsünü

almamızı kendisi teklif etmiş ve hocamızın büstü bu kalıp ile alınan ölçü kullanılarak tarafımdan yapılmıştır (Resim 6). Bu çalışmanın detayları 2012 yılında Adli Bilimler Kongresinde tarafımdan sunulmuştur (Aka, 2012).

Adli Yüz Yapılandırma alanında Prof. Dr. İşcan ve ekibi olarak, Hindistan'da, Pencab Üniversitesi, Adli Bilimler bölümü profesörü olan Prof. Dr. Om Prakash Jasuja ile birlikte, 4-8 Nisan 2005 tarihleri arasında, 60 adli bilimci bilim insanının katıldığı uluslararası bir çalıştay gerçekleştirdik (*National Workshop on Forensic Facial Reconstruction*) (Resim 7 ve 8).

Prof. Dr. Mehmet Yaşar İşcan, bir vatanseverdi ve çok şahsiyetli bir kişiliğe sahipti, isminde bulunan Türkçe karakterli haflerin bile yabancı kaynaklarda Türkçe karakter ile yazılmasını isterdi. Çok disiplinliydi, bilimsel yazışmalarda özen isterdi. Bir gün Balkan kongresi sunumumuz için bir poster hazırlanmıştı, birkaç saat içinde meslektaşlar ile hareket edilecekti. Prof. İşcan posterde bir noktalama hatası fark edince, poster son anda tekrar basıldı ve kongre aracına zor yetişti. Kaynak yazlığında "Arkadaşları" ifadesini beğenmezdi, biz her çalıştığımız bilim insanı ile arkadaş değiliz, "Meslektaşları" şeklinde yazmak daha uygun bir terim olur derdi.



