1. Sergei Mysenko

My name is Mysenko Sergei. I was born in Sovetskaya Gavan' – small city of Khabarovsk Territory. In 2010 I successfully ended Saint-Petersburg state university of economic and got a specialization “Accounting, economic analyses and audit”. Then I entered post-graduate course by Department of Accounting and Audit in Saint-Petersburg state university of economic. During postgraduate studying I found problem that seriously interested me – depreciation of the assets. Widely science research of this theme started in XIX century, but even in our days there is a contradiction in understanding of this category in Accounting, Economic and Management sciences. I realized, that I should explore the history of asset's depreciation and try to combine different views on it in the technic of Accounting. In April 2018 I defended my dissertation on theme “Fixed asset depreciation accounting as the factor of maintance of going concern principle” and became a candidate of economic science (PhD). Today I continuing my research in this area.

I serve as senior lecturer in Saint-Petersburg state university of economic. Also I am a member of the Council of young scientist in our University. We trying to make science research more popular, arranging science and practical conferences, workshops and master-classes for young researchers and lecturers. In the 2017 we established science journal “Hypothesis”, where researchers from Russia and other countries can share the results of their research an get some feedback from others researchers. I'm on editorial board of this journal.

2. Kirill Sivodedov

My name is Kirill Sivodedov. I was born in Novosibirsk. There I have studied in gymnasium. Then I entered the Saint Petersburg State University of Economics where I successfully got bachelor degree in economics. I specialized there on world trade economics. For Now I represent Saint Petersburg State University. I entered faculty of economics in this

university for a master degree and started to study accounting, analysis and audit here. During the learning process I realized that I want to immerse in managerial accounting. Now I do my best to improve my skills in this area. Therefore, I work on a master thesis with a theme related to this. My first chapter is a research of managerial accounting evolution. My goal is to connect the major breakthroughs in history of managerial accounting with political events or economical issues that caused them and assess the impact of these events\ issues. Based on this, I want to draw a conclusion about current state of managerial accounting and its perspectives.

We arrived in Turkey as part of a program of collaboration with Professor Oktay Guvemli foundation (waqf) of accounting and financial history. Our scientific supervisors Dina Lvova and Vyacheslav Sokolov recommended us to professor Guvemli.

The aim of this program is preparing the young scientist for taking a part in *15th World Congress of Accounting Historians* that will be held in Saint – Petersburg in July 2020. Our purpose is build up a relationship with Turkish academicians and make a research in accounting and accounting history together and public the results of this research in international journal. We came to the Turkey only 4 day ago. But we have already met a lot of prominent academicians and got a great impressions. Further we hope that professor Oktay Guvemli will give us a chance to meet academicians which field of scientific interest is the same is ours.

Also, now it is planned to organize sixth international conference as you all know it «Sokolov reading» at our Saint – Petersburg State University in 2019 April. We are very grateful to professor Guvemli, who had participated in many conferences since its beginning, for his support, and, of course, for the support of Turkish scientific community. So we invite you all to come and participate in this conference in our beautiful city Saint – Petersburg.
