## PREPARATION OF MANUSCRIPT (APA 7th Edition)

- 1. Regardless of the category, all submissions must be in size of A4 paper, top, down and right margins are 2.5 cm and left margin is 1.5 cm, adjusted form on the both sides, 1.15 spaced in Times New Roman font with 11 punto size.
- 2. For research, review, study papers and reports, a manuscript should be organized in the following sequence: title page, abstract, keywords, introduction, literature review, research design, findings, discussion, conclusion, recommendations, conflict of interest, acknowledgments (optional), references, appendices.
- 3. Main title is in form of Times New Roman with 14 font size and bold and centered.
- 4. If the study has been presented in a congress or symposium etc. or extracted from a project or thesis; there must be a \* foot note at the end of the title to be explained.
- 5. Author names (with corresponding asterisk) must be 12 font size. Their full name, organizations (university, faculty and department names), city and country information and e- mail addresses must be specified.
- 6. If the manuscript is in English, must contain an `Abstract`, while the manuscripts are in other language (currently Turkish, Arabic, French and Malaya), will be submitted with Executive Summary in English.
- 7. Abstract (150-300 words) should be 11 font size and with 1.0 paragraph space without any citation.
- 8. Executive Summary (500-words) will be outlined as research problem and objectives, introduction of new concept (if any), direct literature link/relations (if any), methodology, findings, conclusion, recommendations.
- 9. Keywords should be between 3-7 words.
- 10. Table, figure, graph etc. contents must take place within the main manuscript as exactly required. Tables and figures must have a 10-font size, unlike the main text. Tables and figures must be aligned left with no text wrapping.
- 11. Titles, subtitles, table and figure captions should be numbered decimally like; 1., 1.1., 1.1.1; 2., 2.1., 2.1.1, ...
- 12. Captions must take place before the tables, while must take place after the figure.

## 1) Citation and References

In the references section, the references should be sorted alphabetically. All sources must be referred in a consistent manner. Journals titles should be abbreviated according to the conventional ISO abbreviations. Examples of some key citations and references are given in the table below. APA 7th Edition Style Guide can be consulted for other citations and references procedures.
